Application

For best results pre-treat with P11 SYSTEM CLEANSER prior to adding P12 NOISE SILENCER. Add P14 SYSTEM INHIBITOR to protect the metallic components in the system.

- 1) Locate the central heating feed and expansion tank.
- 2) Shake the bottle and pour contents into the tank.
- 3) P12 is gradually drawn into the system and provides full effect within 1-6 weeks.
- 4) Bleed radiators after 2-3 days and again after 2-3 weeks.
