




F Typical Inductance vs. Current Characteristics:





- •All products are supposed to be used before the end of the period of 12 months based on the product date-code, if not a 100% solderability can't be warranted.

- Due to heavy weight of the components of size 1014, strong forces and high accelerations might have the effect to damage the electrical connection or to harm the circuit board and will result in the loss of warranty.
