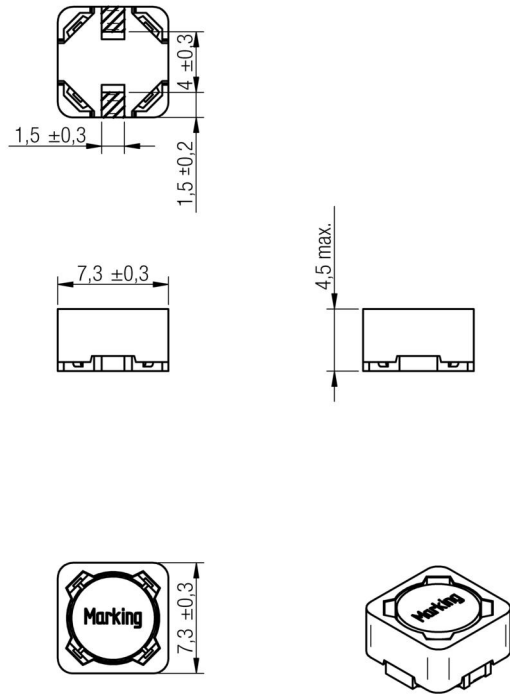

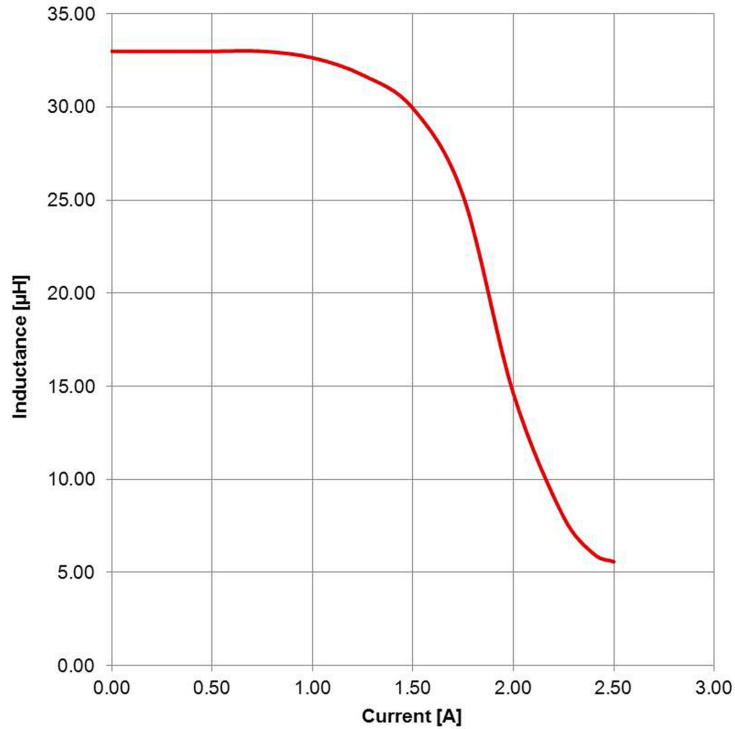

**F Typical Inductance vs. Current Characteristics:**



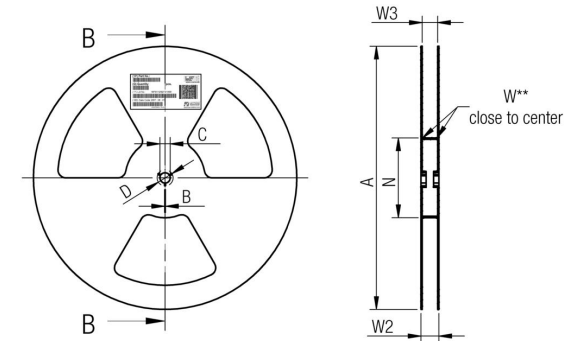



Direct mechanical impact to the product shall be prevented as the core material could flake or in the worst case it could break.


