SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

3.2 POTENTIAL HEALTH EFFECTS

Eye Contact:

6.1. Personal precautions, protective equipment and emergency procedures

SECTION 7: HANDLING AND STORAGE

7.1 HANDLING
