

LM5116 Webench® BuildIt PCB User's Guide

1 Introduction

The LM5116 Webench BuildIt PCB is designed to provide the design engineer with a way to check out their fully functional power converter based Webench Design based on the LM5116 controller IC. The PCB supports the buck topology and allows for wide input voltage ranges from 6V to 100V. The printed circuit board consists of 4 layers, 2 ounce copper top and bottom, 1 ounce copper internal layers on FR4 material with a thickness of 0.062 inches.

The complete details for using this PCB are part of your custom LM5116 buck Webench design, and are located on the BuildIt tab of the Webench Workspace of that design. To access your stored designs start with the [Webench MyDesigns link](#). Once you locate and open your design, click on the BuildIt icon (looks like a shopping cart) and look in the **Documentation** column table for the **Assembly Documentation** link. This document will detail the board layout, the BOM and other details to help you build your custom LM5116 BuildIt kit.

In the LM5116 product folder (<http://www.ti.com/product/LM5116>), you will find a wealth of information about the part, including the *LM5116 Wide Range Synchronous Buck Controller* ([SNVS499](#)) data sheet with complete circuit design information. You will also find the Webench start panel so that you can create a new customized design for the LM5116.

The performance of this evaluation PCB is as follows:

- Input Range: 7V to 100V
- Output Voltage: positive voltages only (buck configuration)
- Output Current: 0 to 20A
