


- The Blue source color devices are made with InGaN on Sapphire-substrate Light Emitting Diode.

- All devices, equipments and machineries must be electrically grounded.







Reflow Soldering Profile For Lead-free SMT Process.




- 1.We recommend the reflow temperature 245°C(+/-5°C).The maximum soldering temperature should be limited to 260°C.


 2.Don't cause stress to the epoxy resin while it is exposed
- to high temperature.




Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

Reel Dimension











