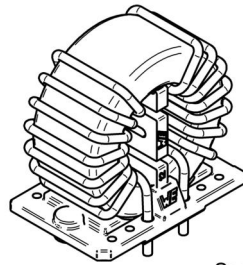

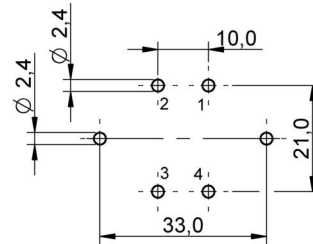



### Product specific:


