1. General description

Planar passivated high commutation three quadrant triac in a SOT186A "full pack" plastic package. This triac is intended for use in motor control circuits where very high blocking voltage, high static and dynamic dV/dt as well as high dI_{com}/dt can occur. This "series C" triac will commute the full rated RMS current at the maximum rated junction temperature without the aid of a snubber.

- High immunity to false turn on by dV/dt
- Isolated mounting base package



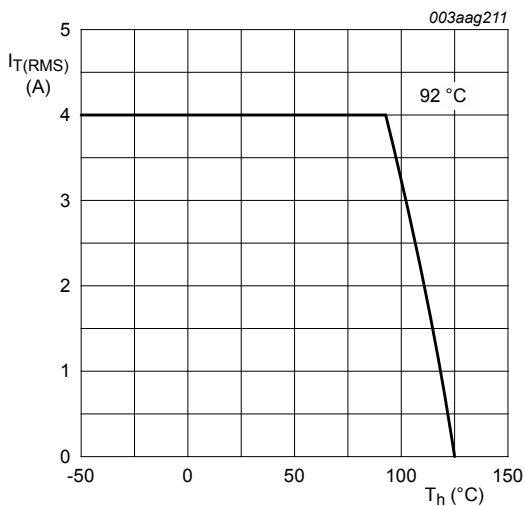


Fig. 1. RMS on-state current as a function of heatsink temperature; maximum values

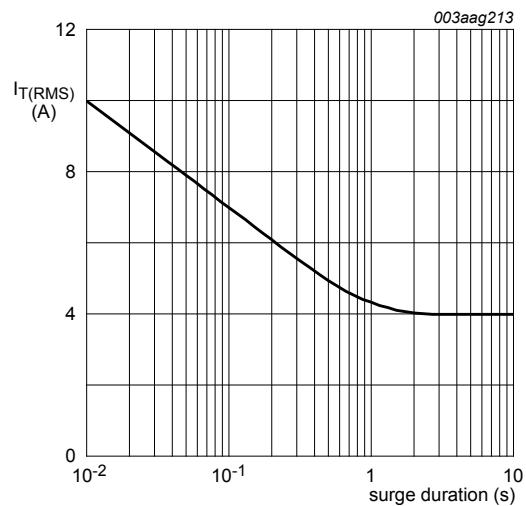


Fig. 2. RMS on-state current as a function of surge duration; maximum values

 $T_h = 92\text{ }^\circ\text{C}$

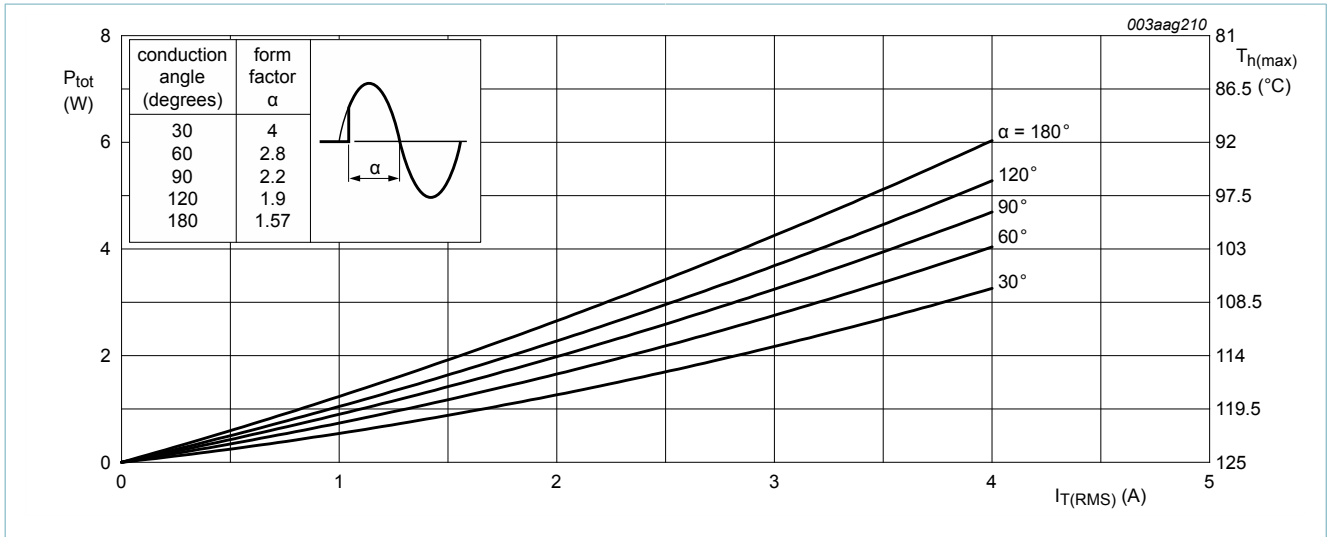


Fig. 3. Total power dissipation as a function of RMS on-state current; maximum values

α = conduction angle

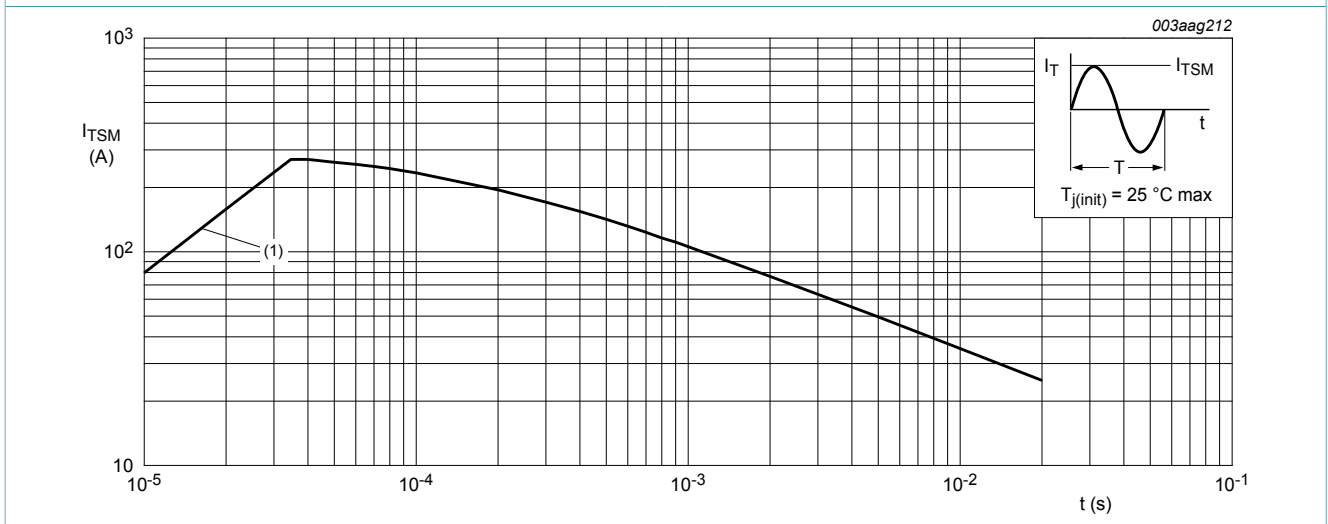
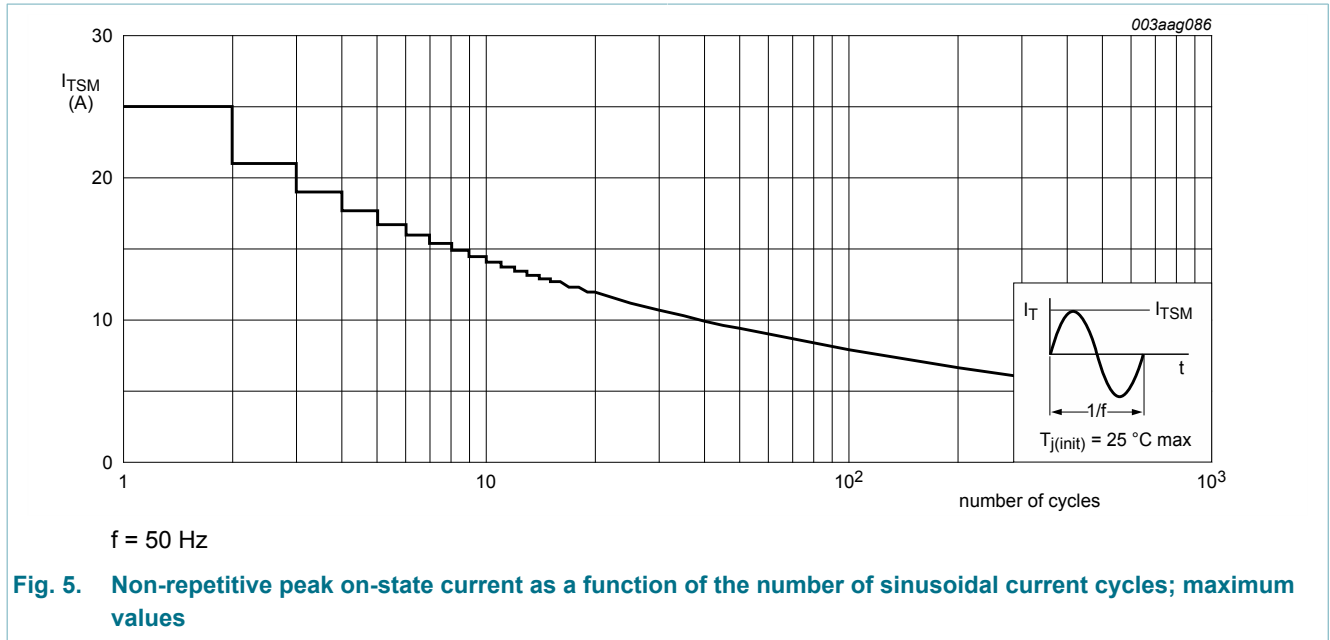


Fig. 4. Non-repetitive peak on-state current as a function of pulse width; maximum values

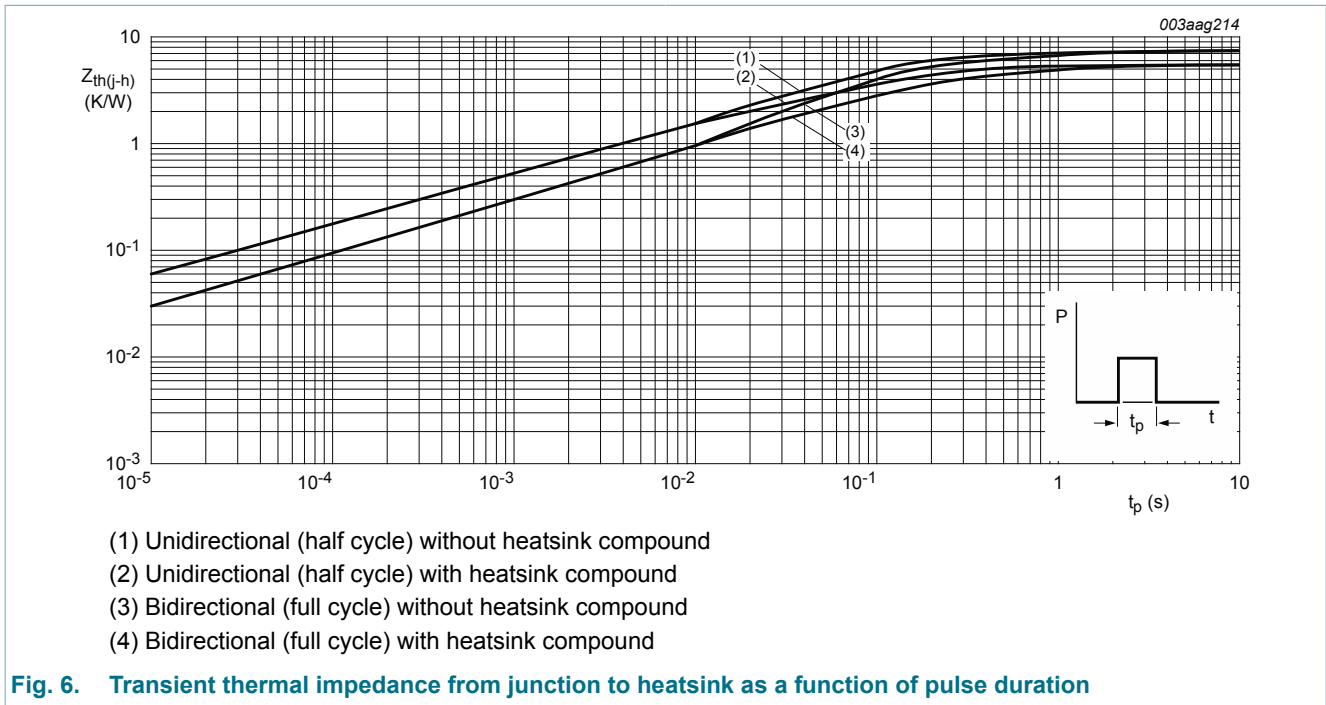

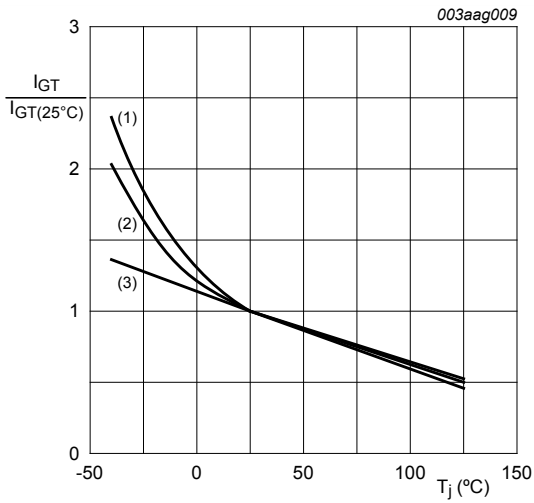


Fig. 7. Normalized gate trigger current as a function of junction temperature

- (3) T2 + G +

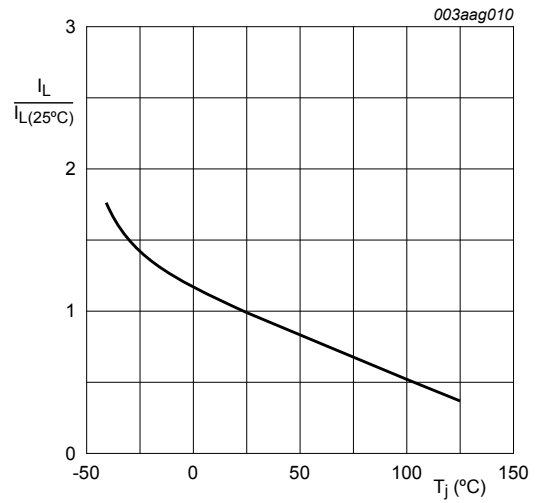


Fig. 8. Normalized latching current as a function of junction temperature

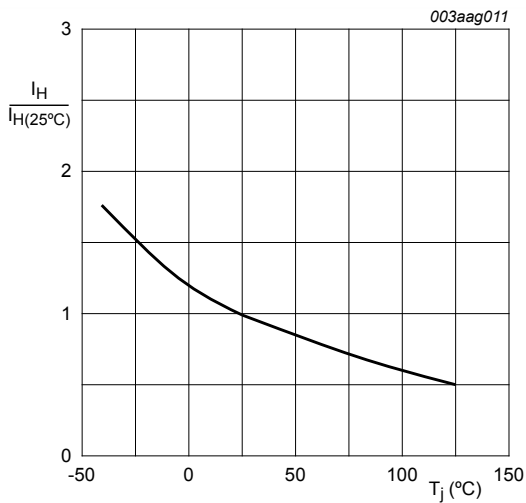


Fig. 9. Normalized holding current as a function of junction temperature

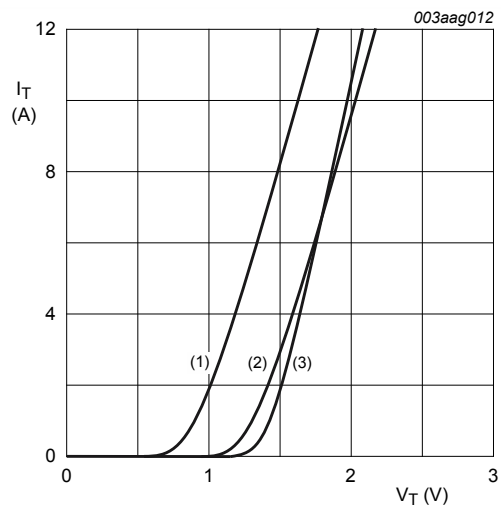
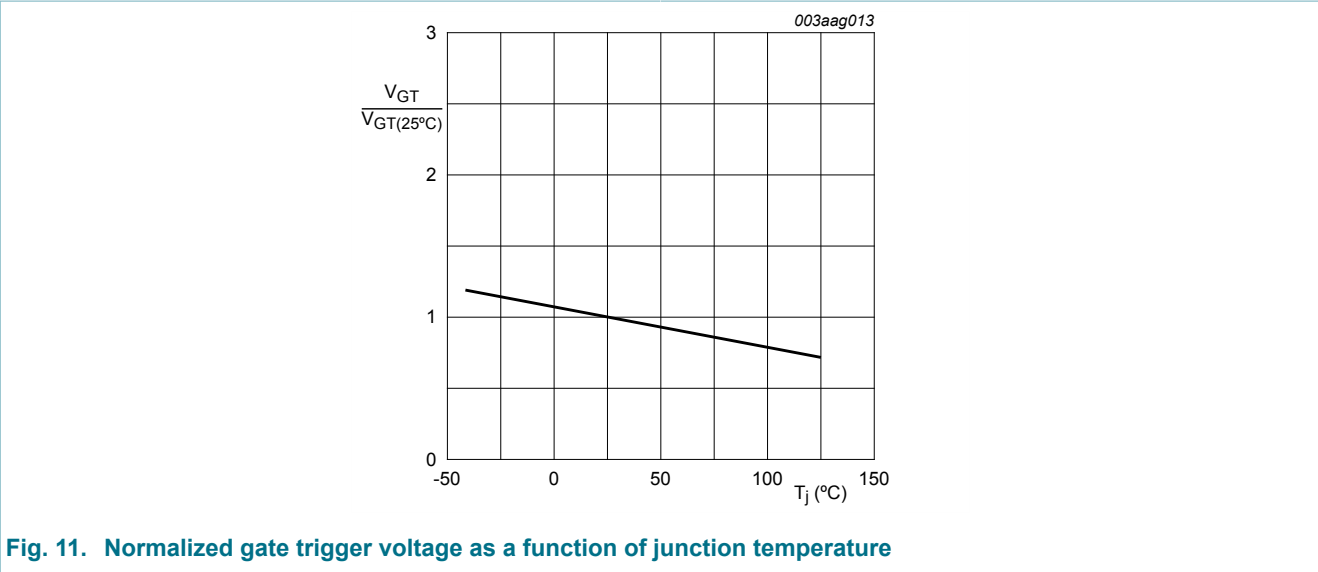


Fig. 10. On-state current as a function of on-state voltage

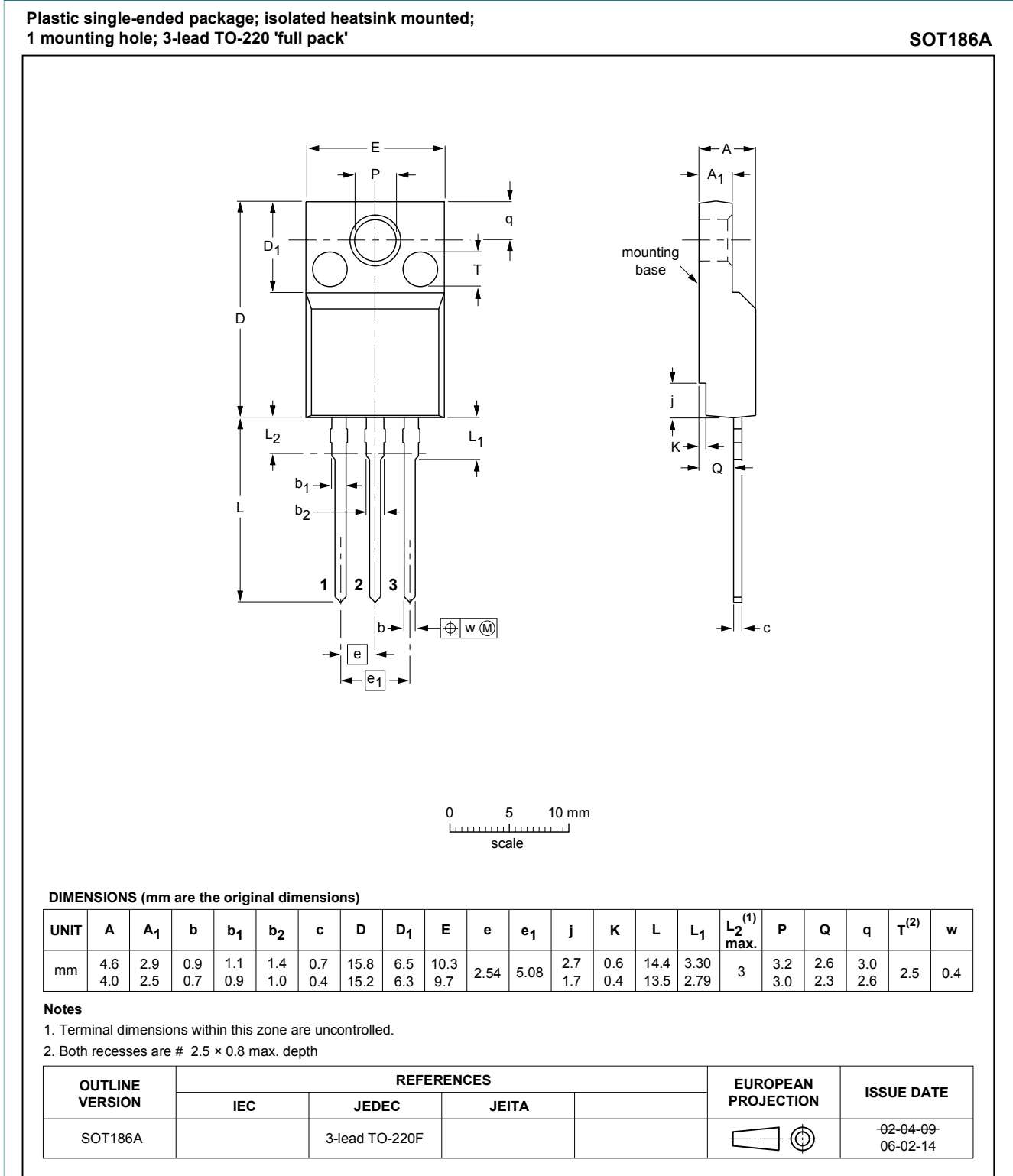


Fig. 12. Package outline TO-220F (SOT186A)
