




Figure 1. DC Current Gain




Figure 2. Collector-Emitter Saturation Voltage




Figure 3. Base-Emitter Saturation Voltage




Figure 4. Collector-Base Leakage Current




Figure 5. Output Capacitance


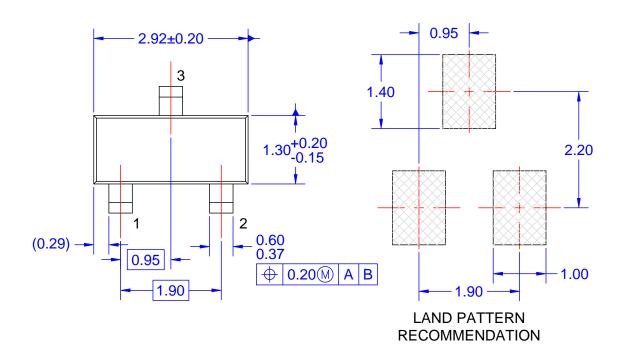
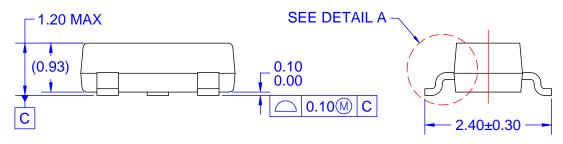
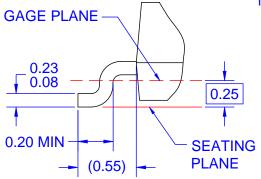


Figure 6. Power Dissipation vs. Ambient Temperature
