




Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage





Fig. 4 - Maximum Allowable Case Temperature



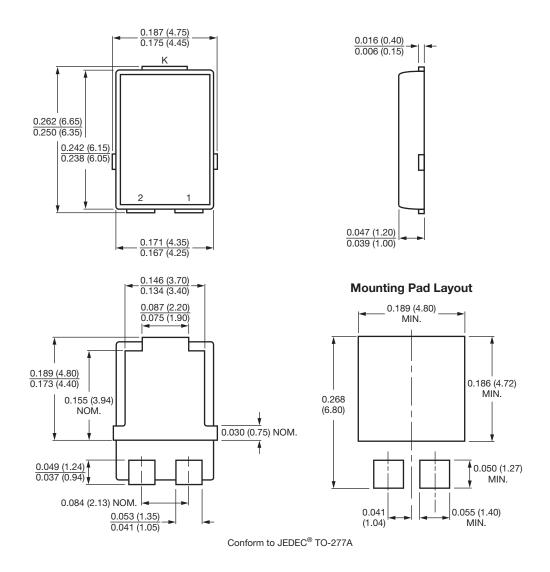
