




Operating Range (Typical) E3R-DS30E4




Excess Gain vs. Set Distance (Typical)








Slit Characteristics (Excess Gain vs. Distance) (Typical)




E39-S5 1-mm-wide Slit






E39-S5 2-mm-wide Slit

E39-S5 Slit

Use the E39-S5 for sensing thin objects or if the sensing position is near the center of the lens. The E39-S5 with 1-mm-wide slit and that with 2-mm-wide slit are available.

The slit on the Emitter and that on the Receiver must be in the same direction.
