


Fig. 1 - Forward Current vs. Ambient Temperature




Fig. 2 - Forward Current vs. Pulse Length




Fig. 3 - Relative Luminous Intensity vs. Angular Displacement




Fig. 4 - Relative Intensity vs. Wavelength




Fig. 5 - Forward Current vs. Forward Voltage




Fig. 6 - Relative Luminous Intensity vs. Forward Current




Fig. 7 - Relative Luminous Intensity vs. Forward Current/Duty Cycle






Fig. 8 - Relative Luminous Intensity vs. Ambient Temperature





## SMD LED (VLM.3 - SERIES)

Vishay's LEDs in SMD packages are available in an antistatic 8 mm blister tape (in accordance with DIN IEC 40 (CO) 564) for automatic component insertion. The blister tape is a plastic strip with impressed component cavities, covered by a top tape.




Fig. 9 - Tape Dimensions in mm for PLCC-2




Fig. 10 - Reel Dimensions - GS08




Fig. 11 - Reel Dimensions - GS18

#### IR Reflow Soldering Profile for lead (Pb)-free soldering Preconditioning acc. to JEDEC level 2a




Fig. 12 - Vishay Leadfree Reflow Soldering Profile (acc. to J-STD-020)





Fig. 13 - Double Wave Soldering of Opto Devices (all Packages)



#### **DRY PACKING**

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



#### **FINAL PACKING**

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

#### RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity ≤ 60 % RH max.


After more than 672 h under these conditions moisture content will be too high for reflow soldering.

In case of moisture absorption, the devices will recover to the former condition by drying under the following condition: 192 h at 40  $^{\circ}$ C + 5  $^{\circ}$ C / - 0  $^{\circ}$ C and < 5  $^{\circ}$ RH (dry air/nitrogen) or

96 h at 60 °C + 5 °C and < 5 % RH for all device containers or

24 h at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC standard JESD22-A112 level 2a label is included on all dry bags.

#### **ESD PRECAUTION**

Proper storage and handling procedures should be followed to prevent ESD damage to the devices especially when they are removed from the antistatic shielding bag. Electro-static sensitive devices warning labels are on the packaging.
