TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






Transfer Characteristics



Capacitance




Normalized Thermal Transient Impedance, Junction-to-Case











Side view of dual


Side view of single

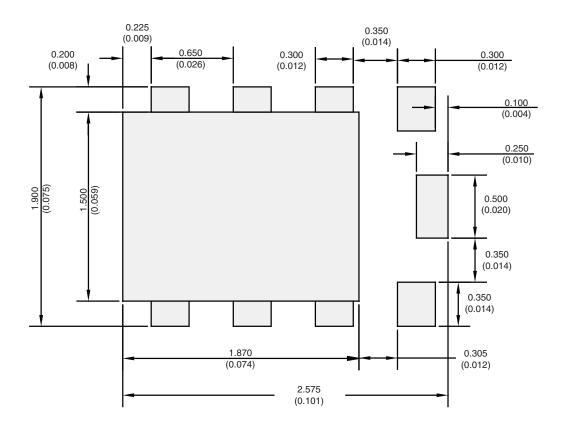
