### **Recommended Land Pattern: [mm]**











# **Peak Pulse Power and Current Derating:**




# **Steady State Power Dissipation Derating:**







## **Maximum Non-Repetitive Forward Surge Current:**




# **Typical Junction Capacitance:**

Signals operated continuously with a high ratio of direct-current voltage might have an influence on the product life time.


#### **Product specific:**
