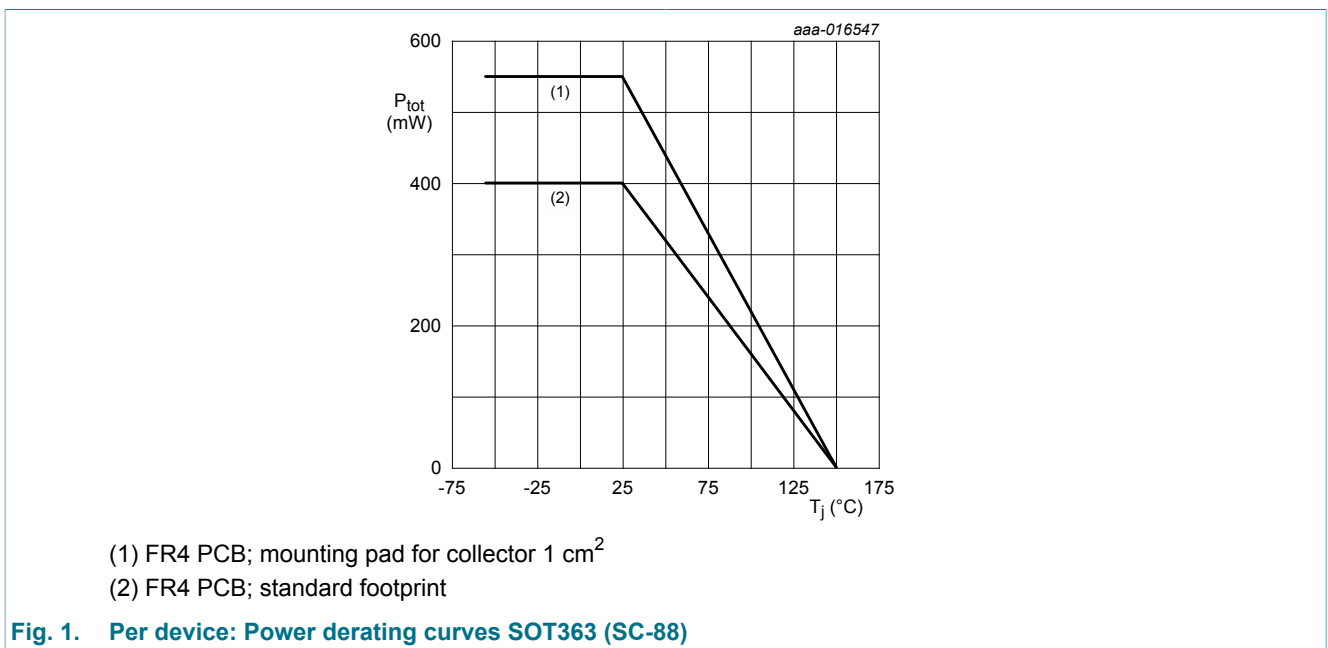


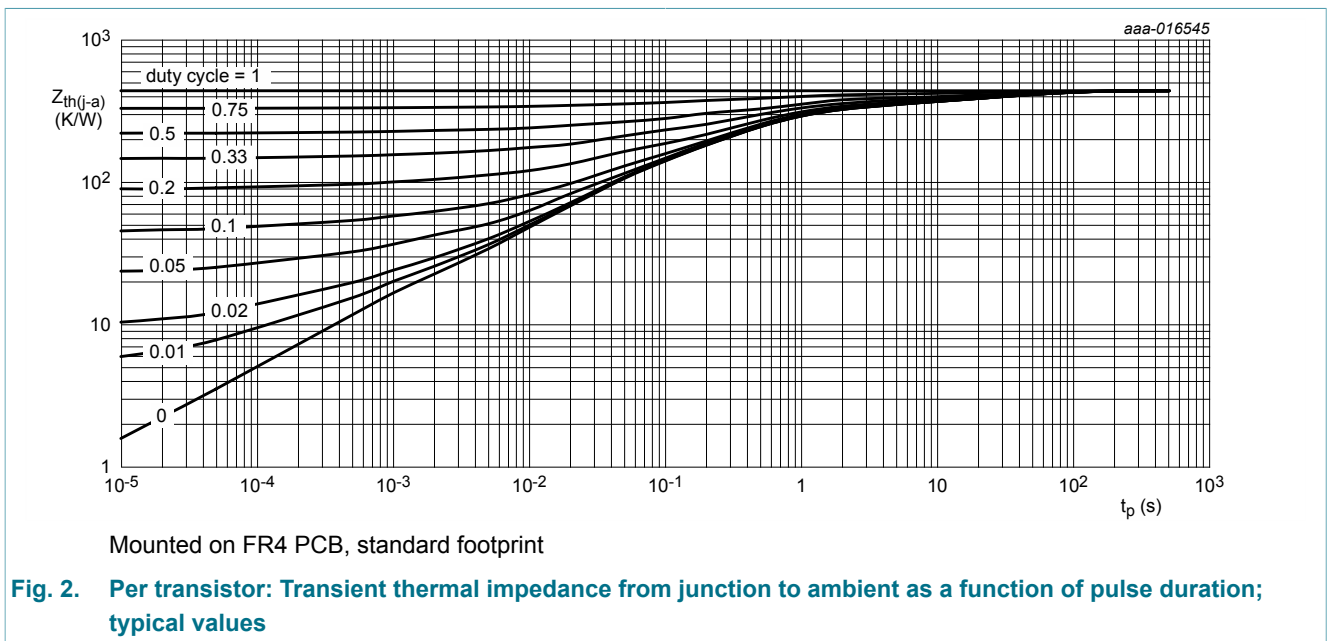
Fig. 1. Per device: Power derating curves SOT363 (SC-88)

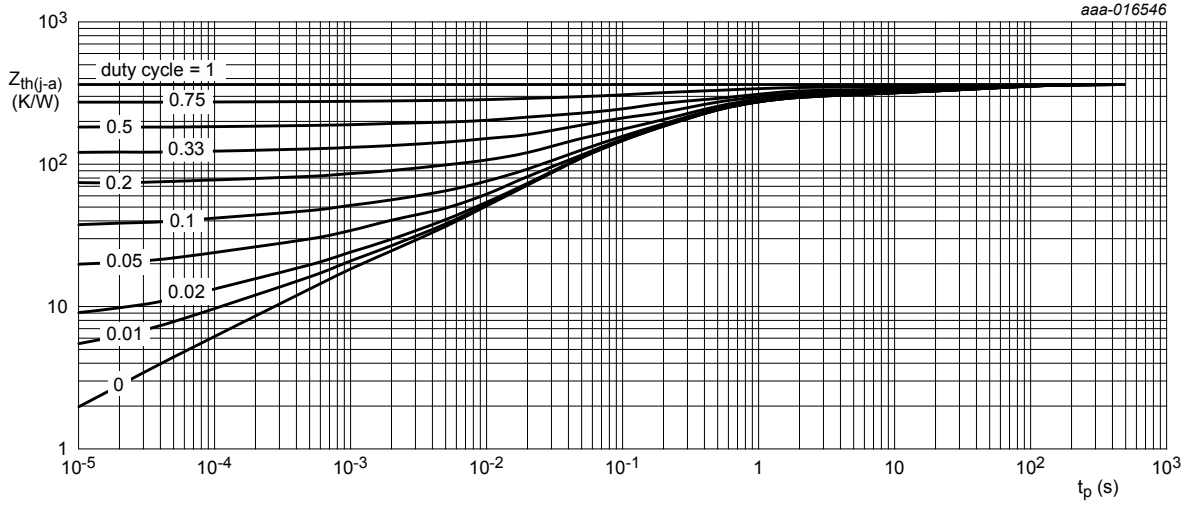

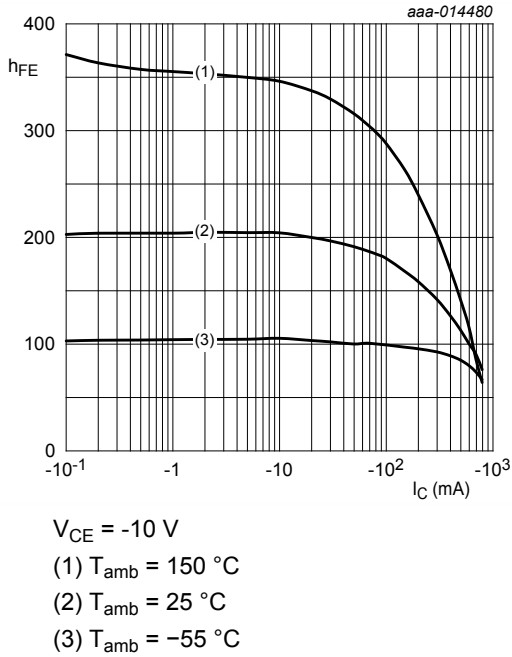


Fig. 4. DC current gain as a function of collector current; typical values

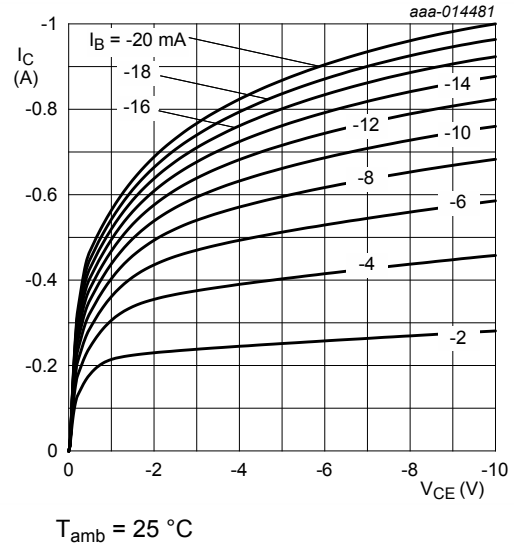


Fig. 5. Collector current as a function of collector-emitter voltage; typical values

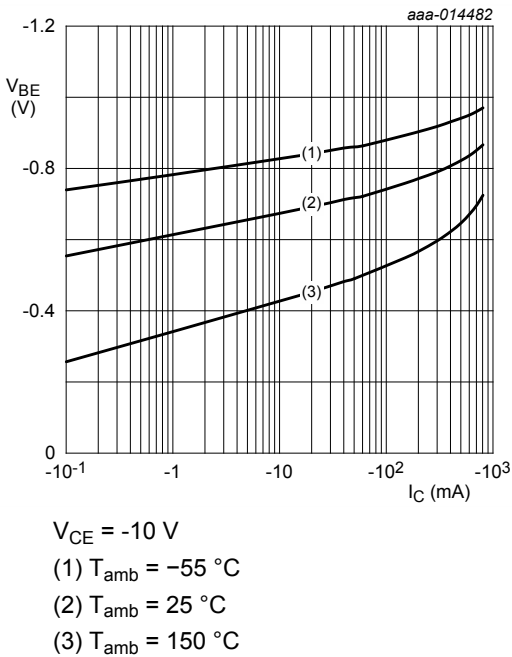


Fig. 6. Base-emitter voltage as a function of collector current; typical values

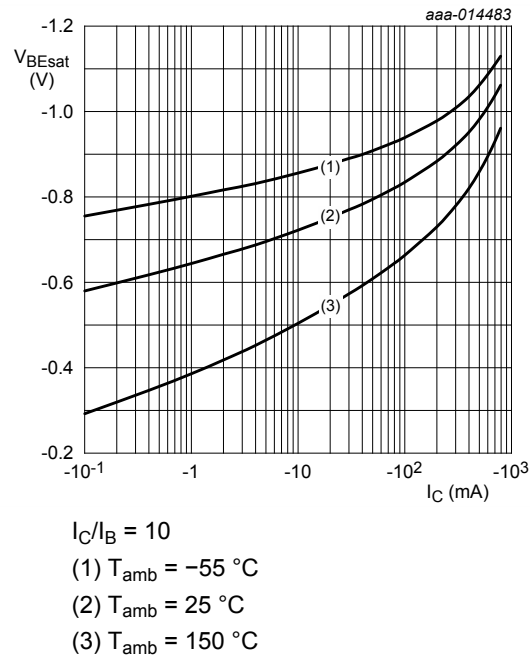
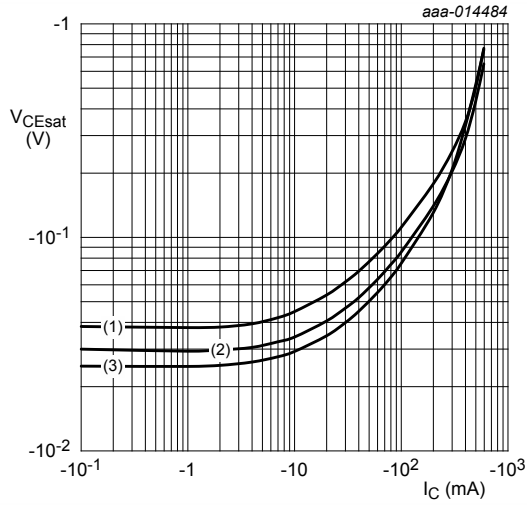
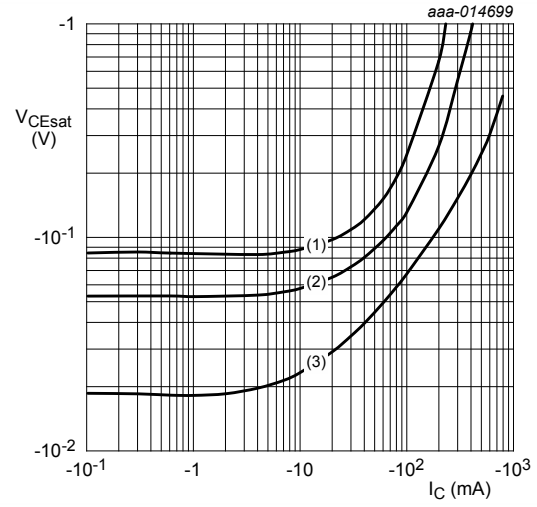


Fig. 7. Base-emitter saturation voltage as a function of collector current; typical values

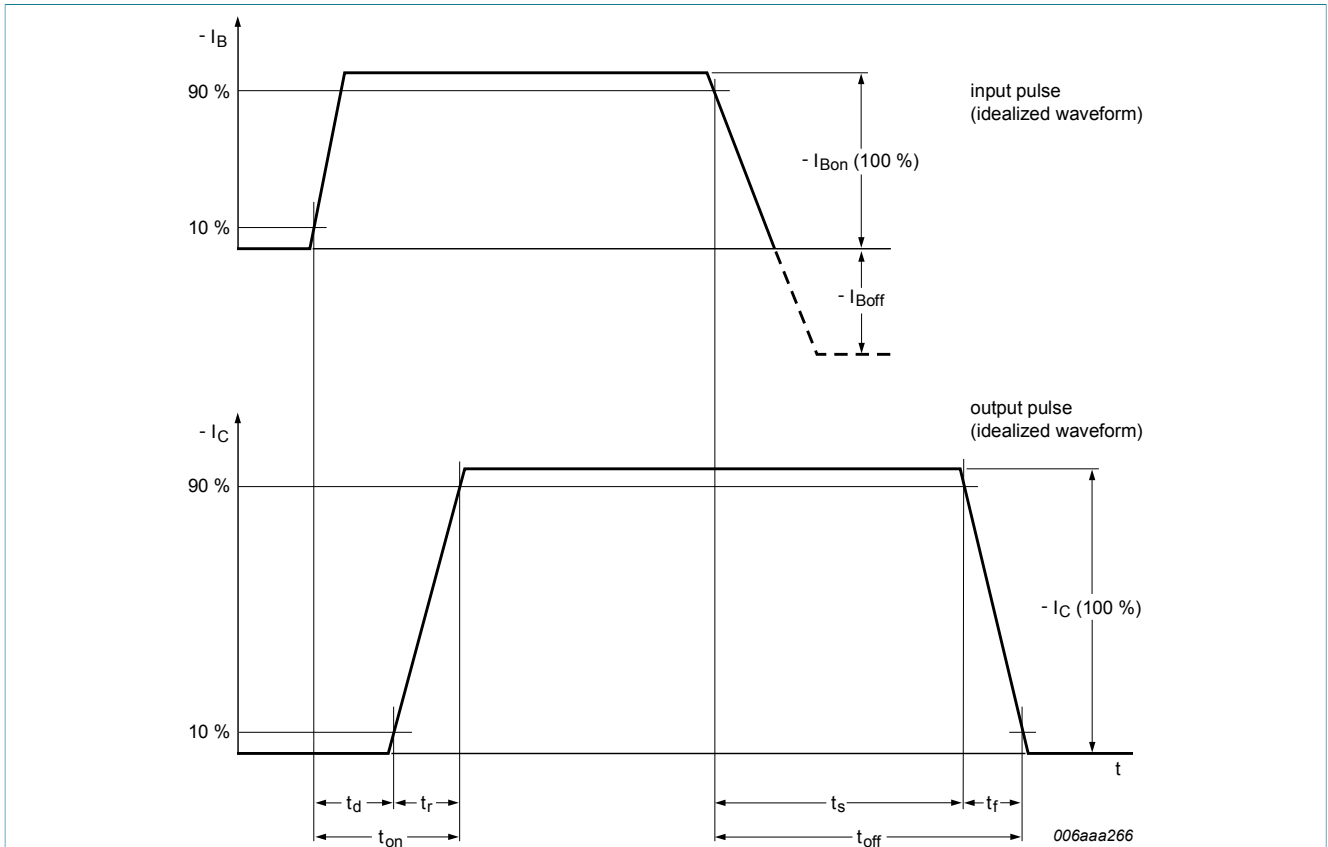


Fig. 10. BISS transistor switching time definition

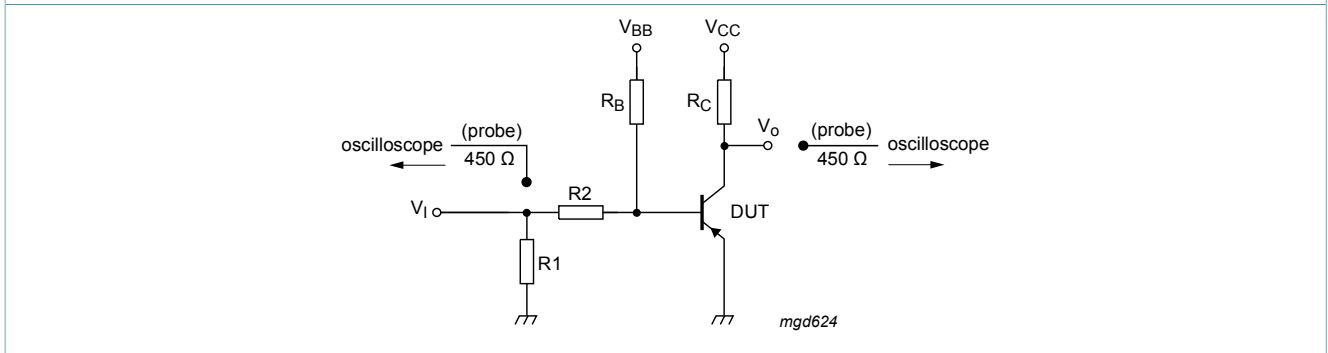


Fig. 11. Test circuit for switching times

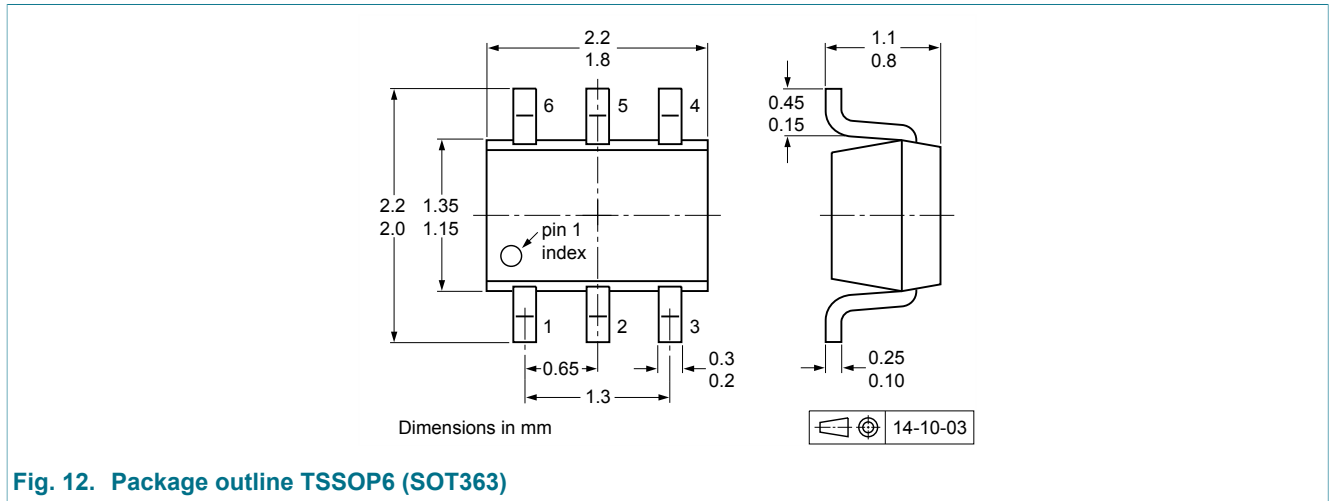


Fig. 12. Package outline TSSOP6 (SOT363)

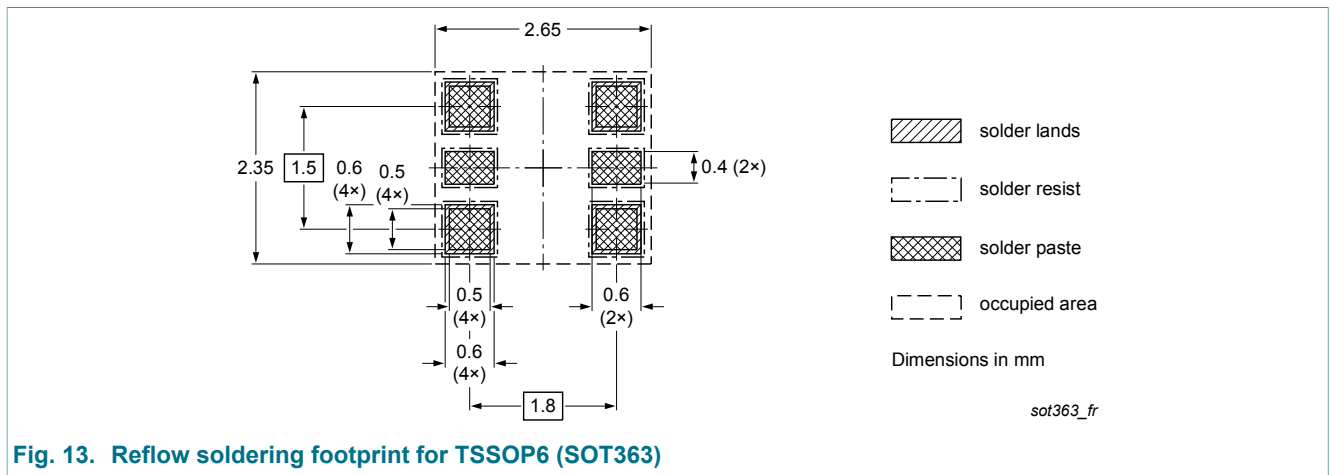


Fig. 13. Reflow soldering footprint for TSSOP6 (SOT363)

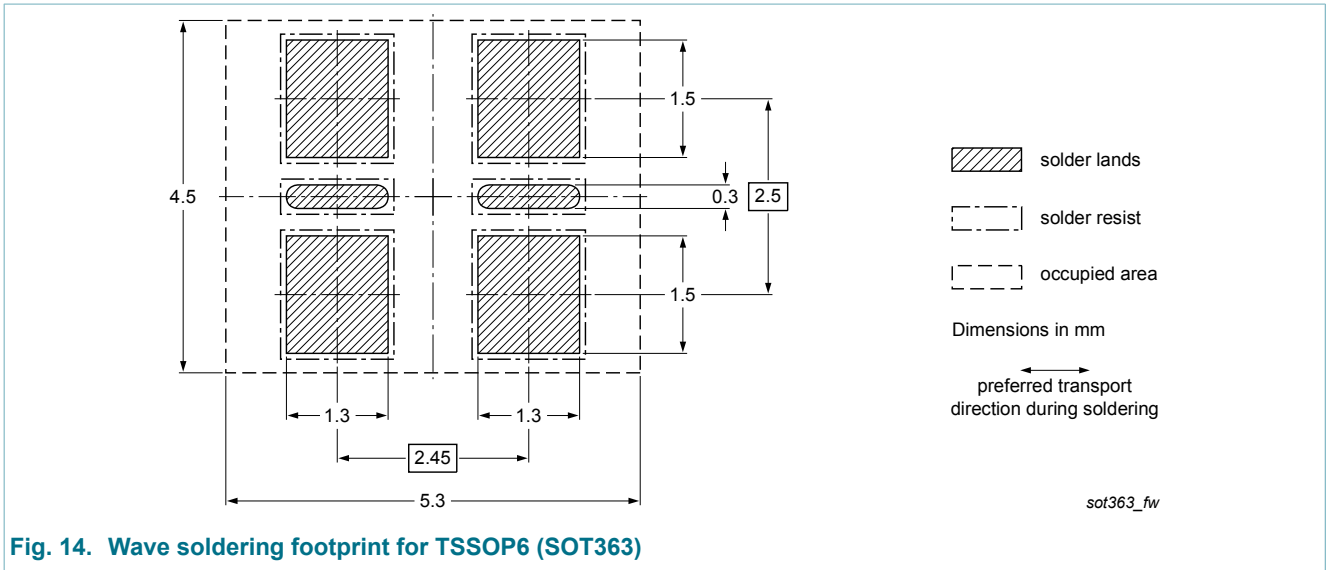


Fig. 14. Wave soldering footprint for TSSOP6 (SOT363)
