




V<sub>SD</sub> - Source-to-Drain Voltage (V) **Source-Drain Diode Forward Voltage**





Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot

On-Resistance vs. Gate-to-Source Voltage










