




Figure 1. DC Current Gain




Figure 2. Saturation Voltage




Figure 3. Capacitance




Figure 4. Current Gain Bandwidth Product




Figure 5. Active-Regio Safe Operating Area




Figure 6. 3-LEAD, SOT23, JEDEC TO-236, LOW PROFILE (ACTIVE)
