# **Approximate Implementation Date:**

Effective 90 days from the date of this notification or upon customer approval, whichever comes first, all shipments of the affected part numbers in the attached file will be supplied from any of the qualified manufacturing sites.

### Anticipated Impact:

Products manufactured at Fab 25 site are completely compatible with existing product from a functional, parametric, and quality performance perspective.

Cypress recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

# Method of Identification:

There will be no changes to the part number. Cypress maintains traceability of product to wafer level, including wafer fabrication location and assembly location, through the lot number marked on the package. There will be no changes to the ordering codes or marking on production material after the change implementation date.
