# **Description of Change:**

Cypress has qualified a new tray (supplied by Daewon) intended for 44-lead TSOP II product shipments. The new tray will serve as an alternative tray source. The tray pocket dimensions are specially modified to improve the unit placement and the stability needed during assembly until product shipment. The table below summarizes the tray pocket dimension comparison:

#### **Qualification Status:**

This alternative tray for 44-lead TSOP II package has been qualified through a series of tests identified in the Qualification Test Plan (QTP) Report 142505. The QTP report can be found as an attachment to this notification or by visiting <u>www.cypress.com</u> and typing the QTP number in the keyword search window.

#### Sample Status:

Tray samples are available. Please contact your sales representative as soon as possible, but within 30 days of the date of this PCN, to place any tray sample orders.

#### **Approximate Implementation Date:**

This change will be implemented 90 days from the date of this notification. Effective 90 days from the date of this notification, all shipments of the affected part numbers will be supplied with either Daewon or Kostat trays.

# **Anticipated Impact:**

The new tray is non-stackable with the existing tray. Therefore, it is not recommended to combine new and existing trays during processing in the equipment. Cypress also recommends that customers review these changes against their current pick and place programs and equipment parameters to assess if any minor adjustments are needed while using these trays.

# Method of Identification:

The newly qualified tray can be identified through external visual inspection (naked eye). The tray part number is written on the side tab of the tray. Please refer to the tray drawing in the attachment.
