

Description

This monolithic integrated circuit is an adjustable 3-terminal positive voltage regulator designed to supply more than 1.5 A of load current with an output voltage adjustable over a 1.2 V to 57 V. It employs internal current limiting, thermal shut down and safe area compensation.

Block Diagram




Figure 1. Block Diagram




Figure 2. Load Regulation




Figure 4. Dropout Voltage




Figure 3. Adjustment Current





Figure 5. Reference Voltage




 $V_0 = 1.25V (1 + R_2/R_1) + I_{adj}R_2$

3. C_i is required when regulator is located an appreciable distance from power supply filter. C_o is not needed for stability, however, it does improve transient response. Since I_{ADJ} is controlled to less than 100 μ A, the error associated with this term is negligible in most applications.
