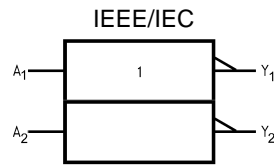


Figure 1. Logic Symbol

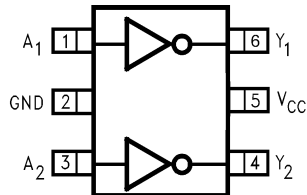


Figure 2. SC70 (Top View)

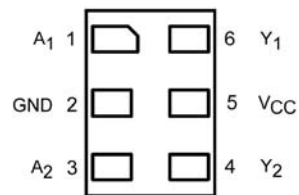


Figure 3. MicroPak (Top Through View)

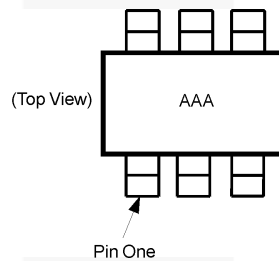


Figure 4. Pin 1 Orientation

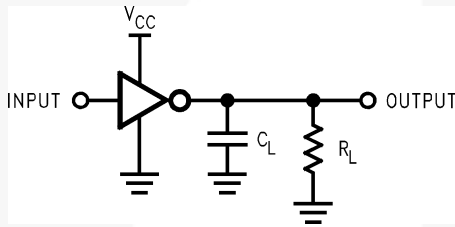


Figure 5. AC Test Circuit

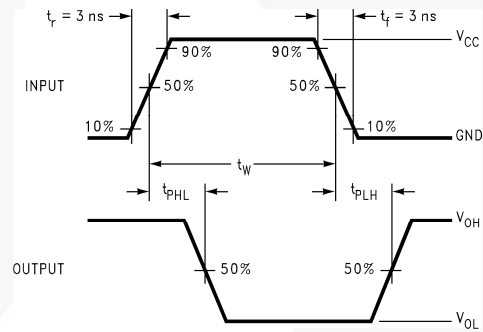


Figure 6. AC Waveforms

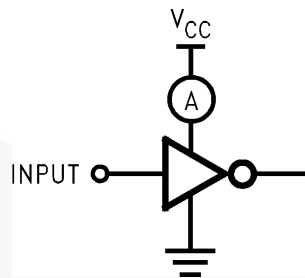
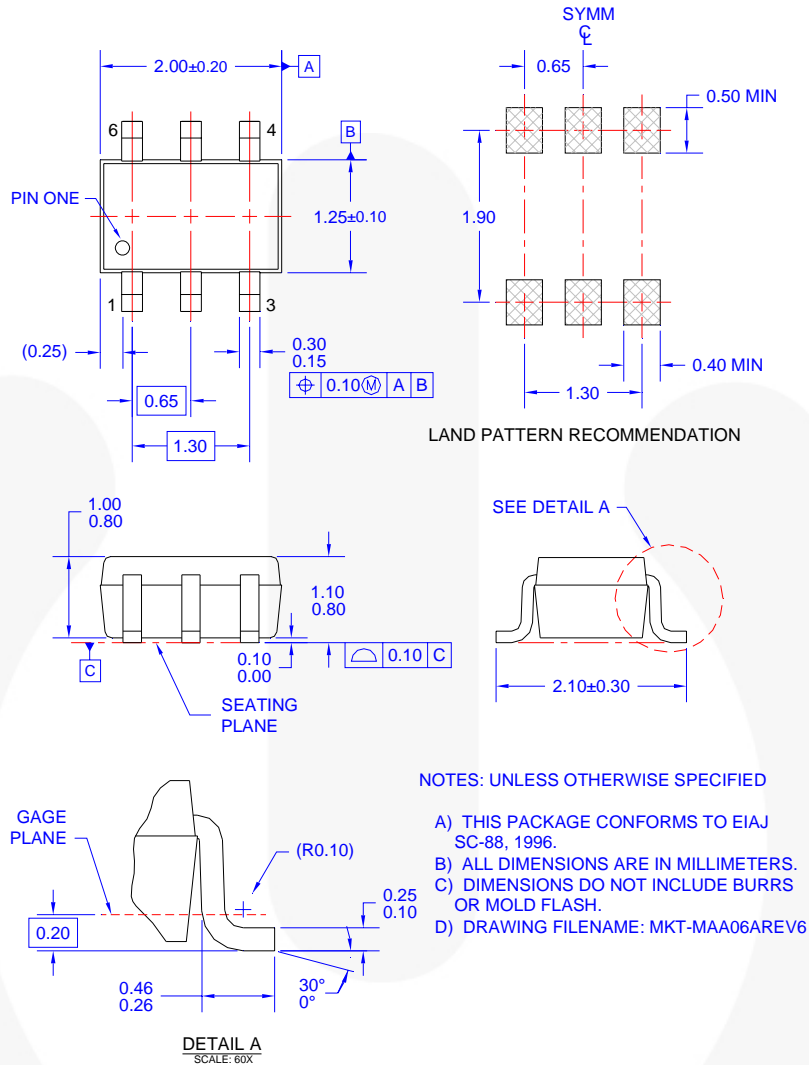


Figure 7. I<sub>CCD</sub> Test Circuit

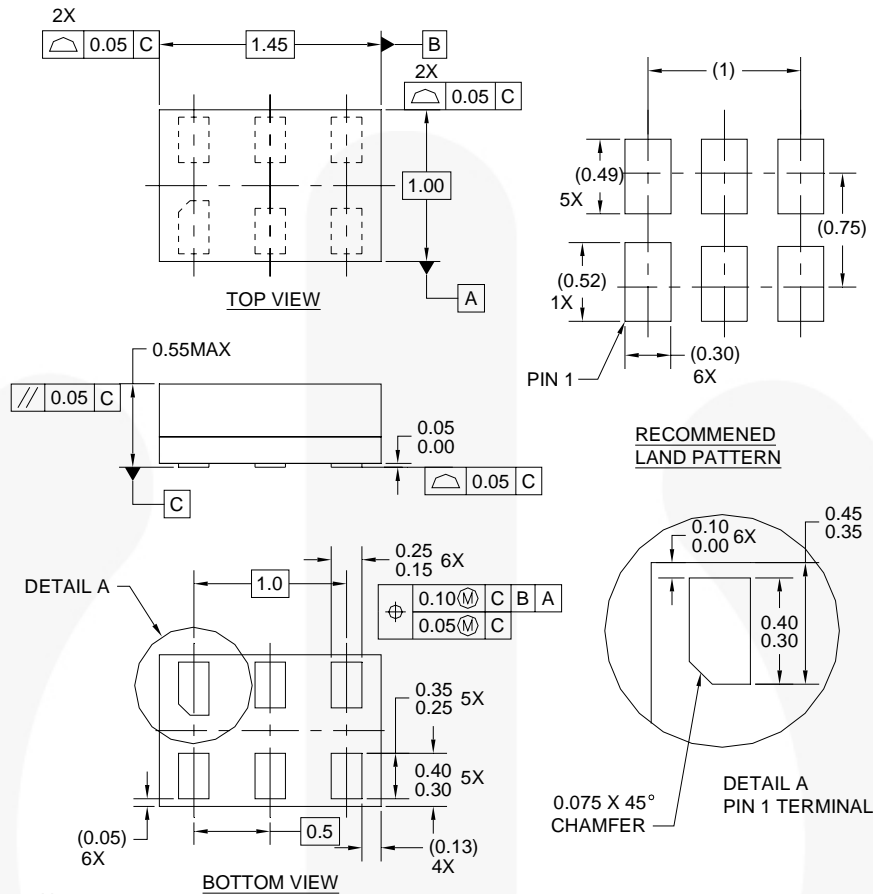

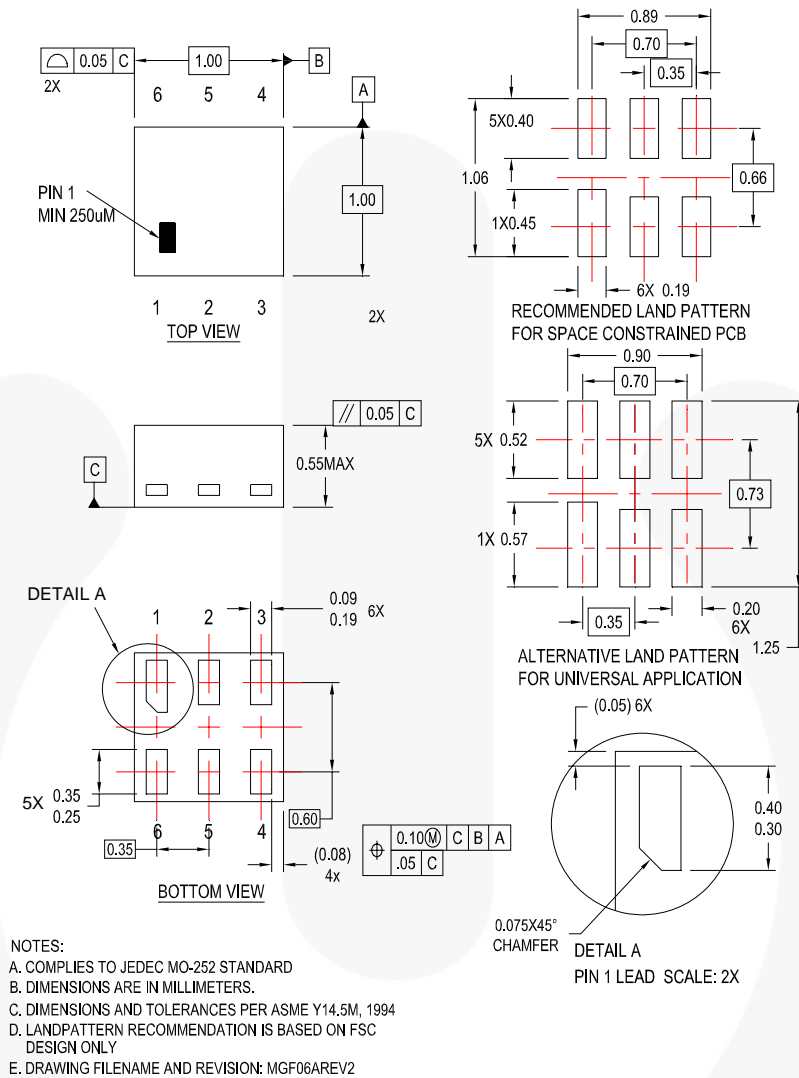
