


General Description

SyncFET Schottky body diode Characteristics




Figure 14. FDMS8026S SyncFET body diode reverse recovery characteristic

Fairchild's SyncFET process embeds a Schottky diode in parallel with PowerTrench MOSFET. This diode exhibits similar characteristics to a discrete external Schottky diode in parallel with a MOSFET. Figure 14 shows the reverse recovery characteristic of the FDMS8026S.

Schottky barrier diodes exhibit significant leakage at high temperature and high reverse voltage. This will increase the power in the device.


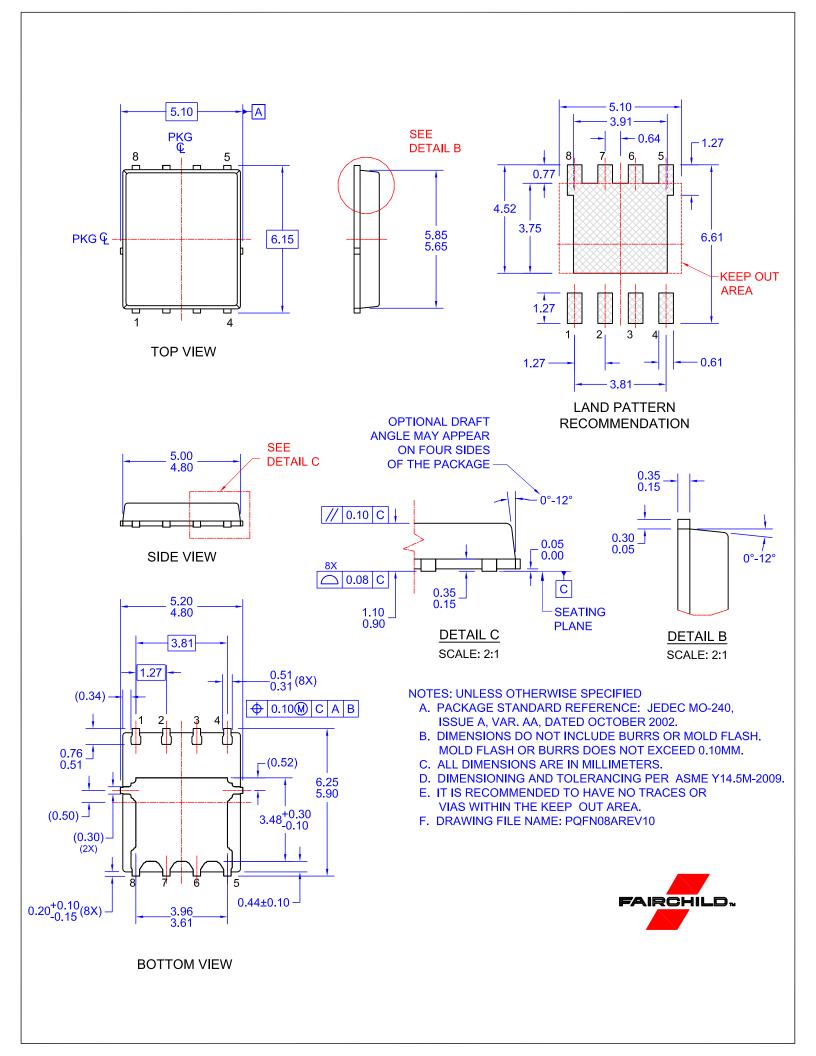


Figure 15. SyncFET body diode reverse leakage versus drain-source voltage
