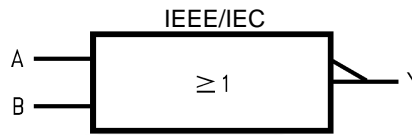


Figure 1. Logic Symbol

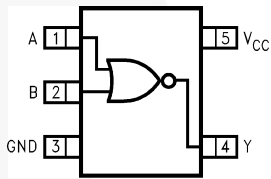


Figure 2. SC70 and SOT23 (Top View)

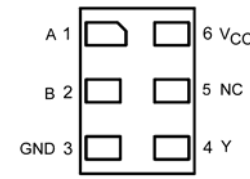


Figure 3. MicroPak™ (Top Through View)

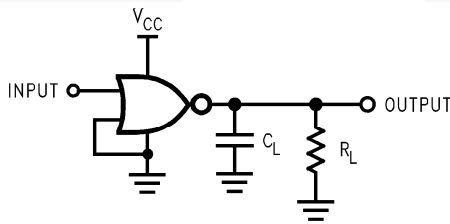


Figure 4. AC Test Circuit

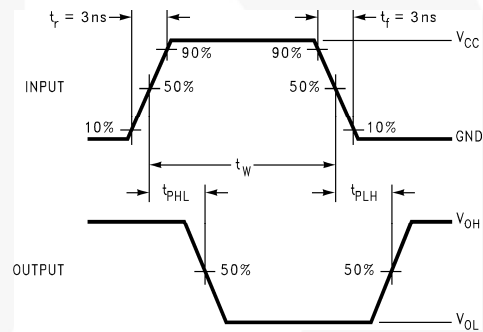
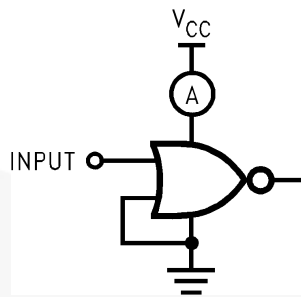


Figure 5. AC Waveforms

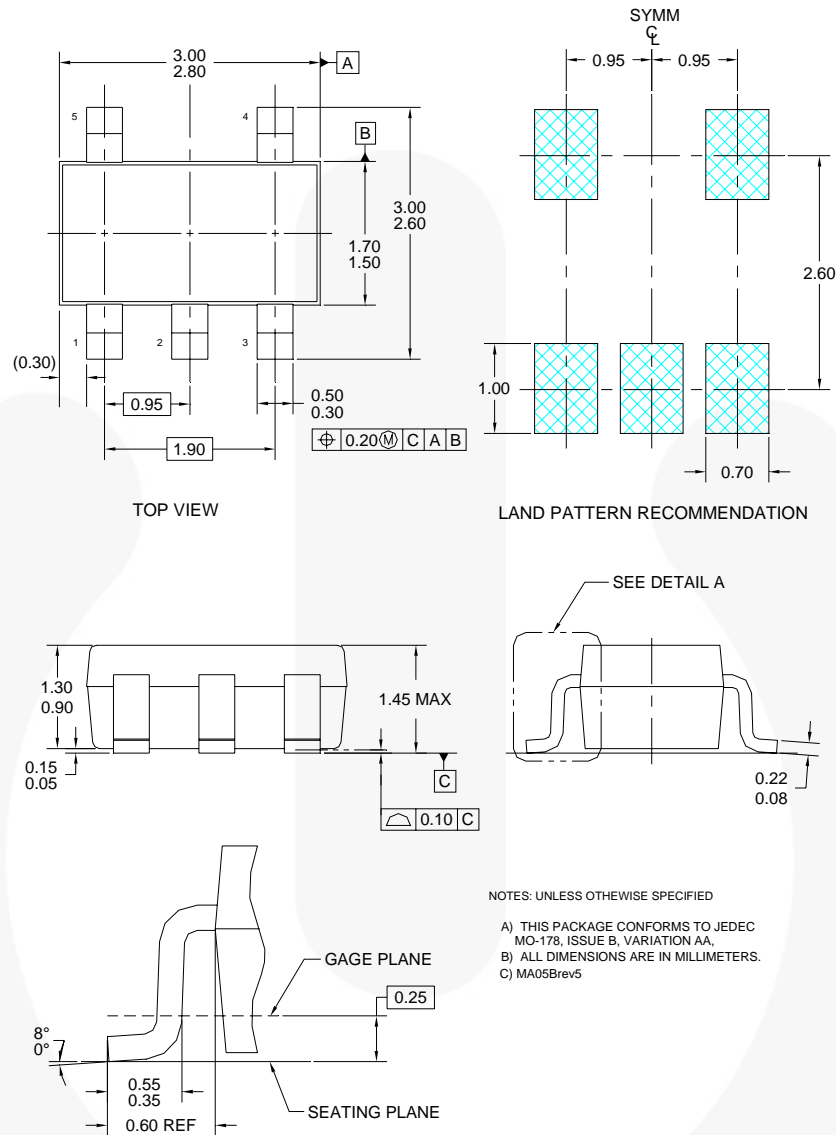


Figure 7. 5-Lead SOT23, JEDEC MO-178 1.6mm

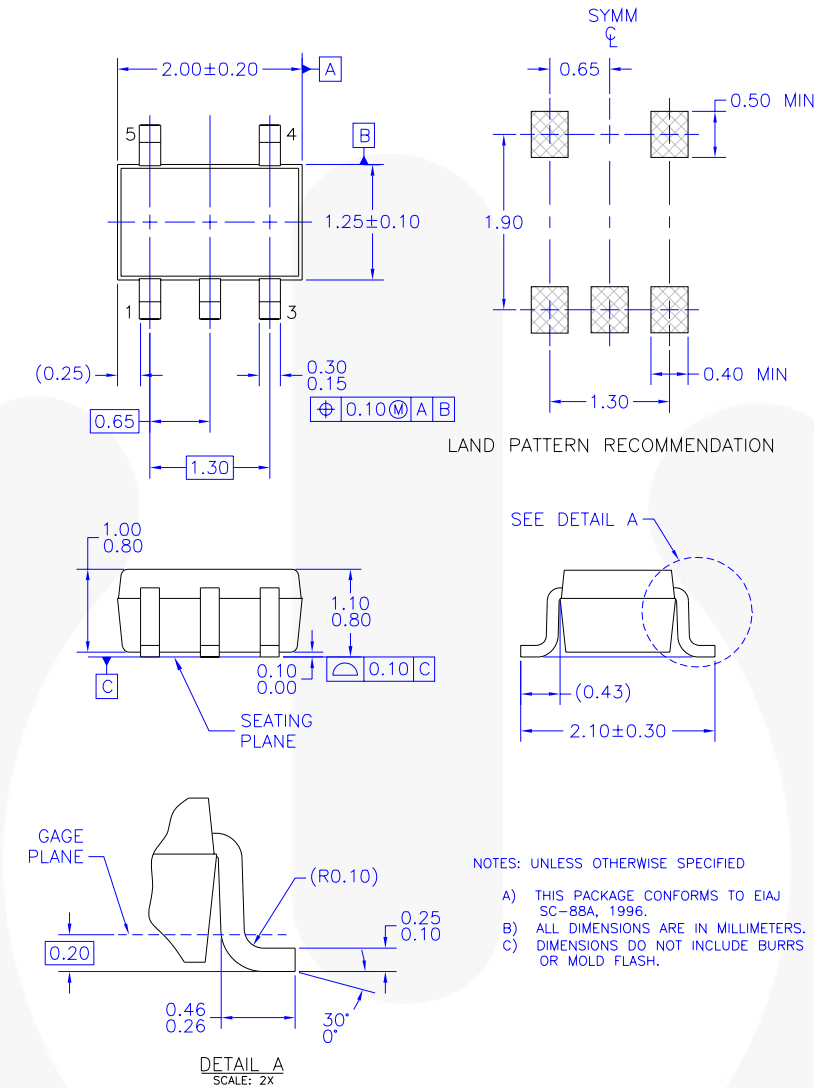

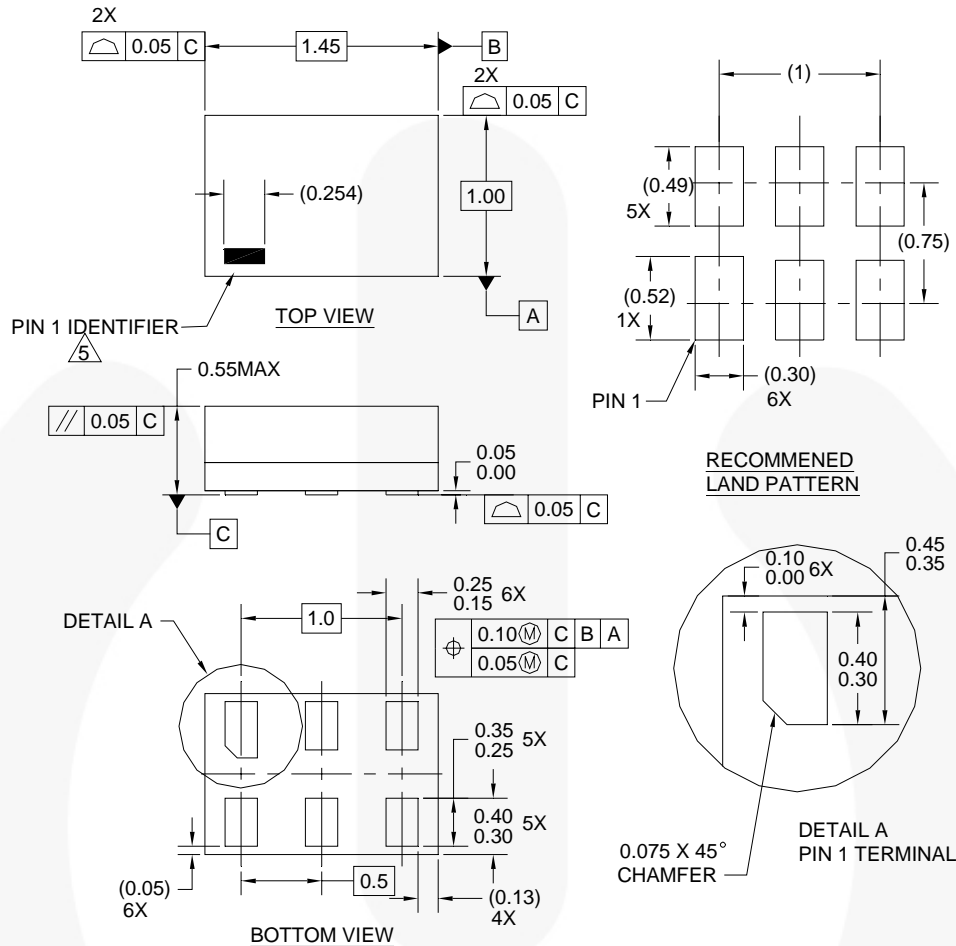

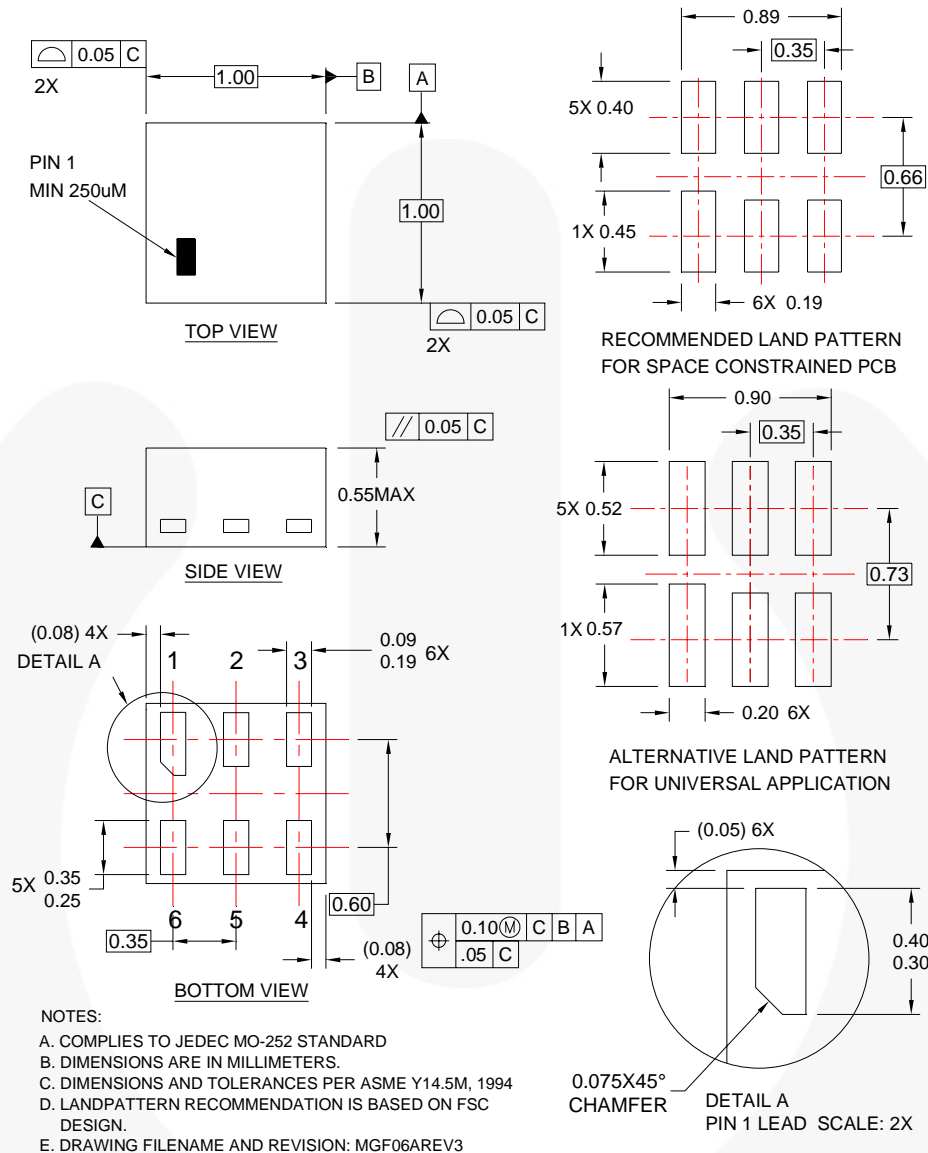


Figure 10.6-Lead, MicroPak2™, 1x1mm Body, .35mm Pitch
