# **Description of Change:**

Cypress announces the qualification of Cypress Fab 25 in Austin, Texas as an additional site for the fabrication of micro-controllers (MCU) products that are currently fabricated at Fujitsu Semiconductor Manufacturing, Inc. Japan (AFSM).

New part numbers are created for Fab 25 products to enable identification of the wafer fabrication facility. LSI chip marking will not change. Cypress requests customers to order Fab 25 products using the new part number. Affected products are listed in the attached table.

### **Benefit of Change:**

This qualification is part of Cypress's continuous improvement in our flexible manufacturing initiative providing Cypress with the added capability to meet upside market demand, reduce business continuity risk, and ensure consistent and reliable delivery to customers in dynamic, changing market conditions.

Effective 90 days from the date of this notification or upon customer approval, whichever comes first, all shipments of the affected part numbers in the attached file may be sourced from Fab 25 in Austin, Texas or from the other qualified manufacturing sites.

## **Anticipated Impact:**

There is no anticipated impact associated with the transfer to product form, fit, function, performance, reliability, quality or product delivery.

Cypress recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

#### Method of Identification:

Cypress maintains traceability of product to wafer level, including wafer fabrication location, through the lot number marked on the package.
