This change will be reflected in UL Certification File QMFZ2.E36952 effective immediately.

With the exception of this change, RTV133 will continue be manufactured using the same material inputs, from the same sources of supply, on the same production systems, according to the same base formulations, and will continue to meet all test specifications reported in our certificate of analysis.
