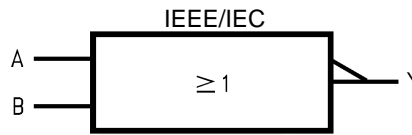


Figure 1. Logic Symbol

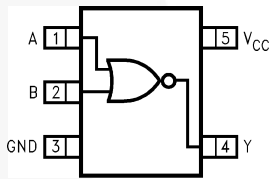


Figure 2. SC70 and SOT23 (Top View)

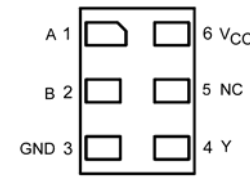


Figure 3. MicroPak™ (Top Through View)

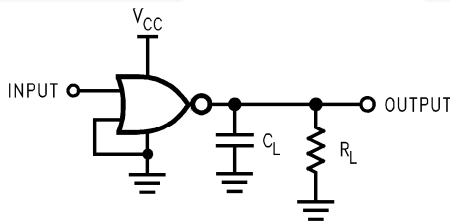


Figure 4. AC Test Circuit

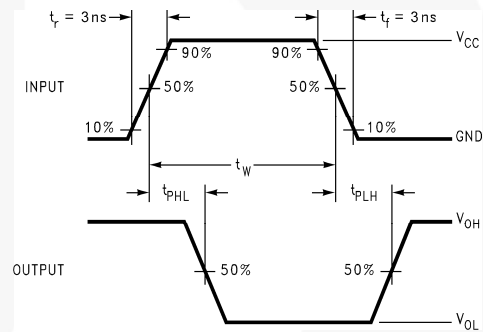


Figure 5. AC Waveforms

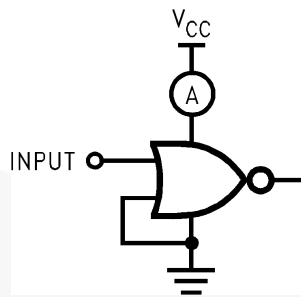
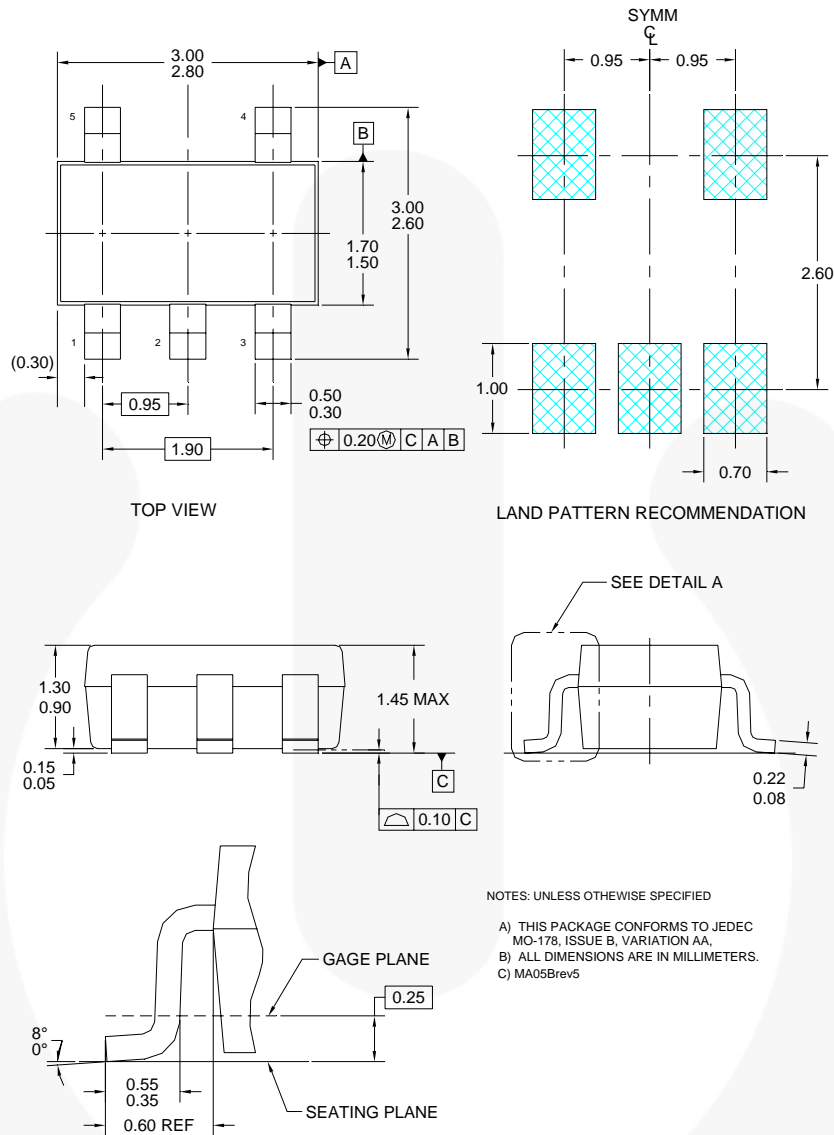


Figure 6. I<sub>CCD</sub> Test Circuit
