


Figure 1. DC Current Gain




Figure 2. Saturation Voltage




Figure 3. Saturation Voltage




Figure 4. Emitter Cut Off Current




Figure 5. Collector CutOff Current




Figure 6. Base-Emitter On Voltage




Figure 7. Output Capacitance




Figure 8. Input Capacitance




Figure 9. Current Gain Bandwidth Product




Figure 10. Resistive Load Switching





Figure 11. Resistive Load Switching
