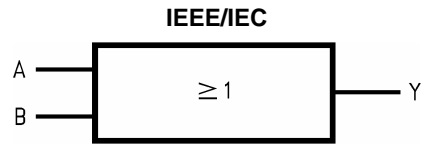


Figure 1. Logic Symbol

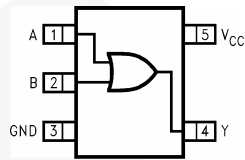


Figure 2. SC70 and SOT23 (Top View)

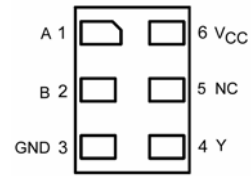


Figure 3. MicroPak (Top Through View)

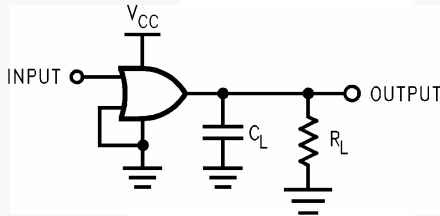


Figure 4. AC Test Circuit

3. C_L includes load and stray capacitance. Input PRR=10MHz t_w=500ns.

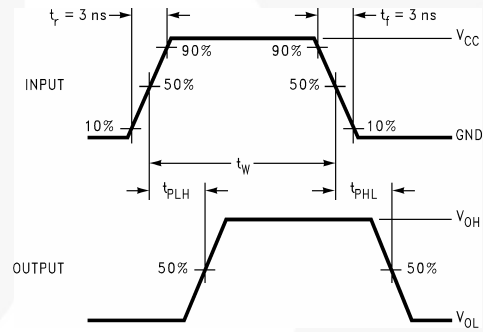


Figure 5. AC Waveforms

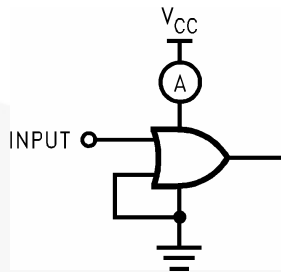


Figure 6. I_{CCD} Test Circuit

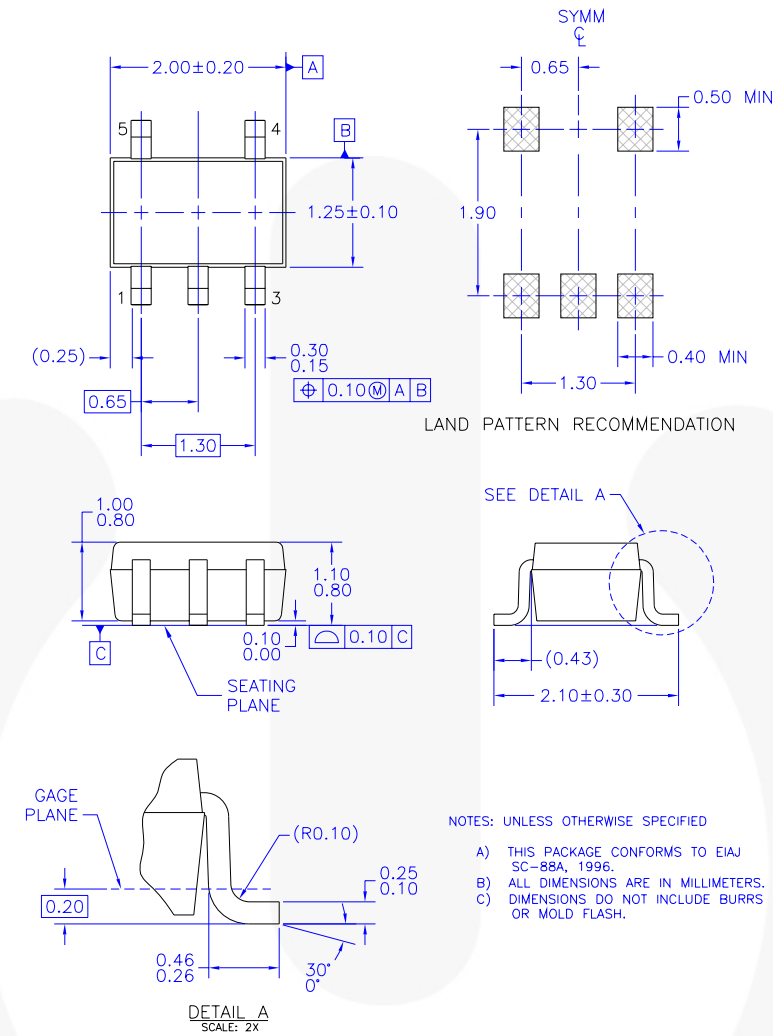

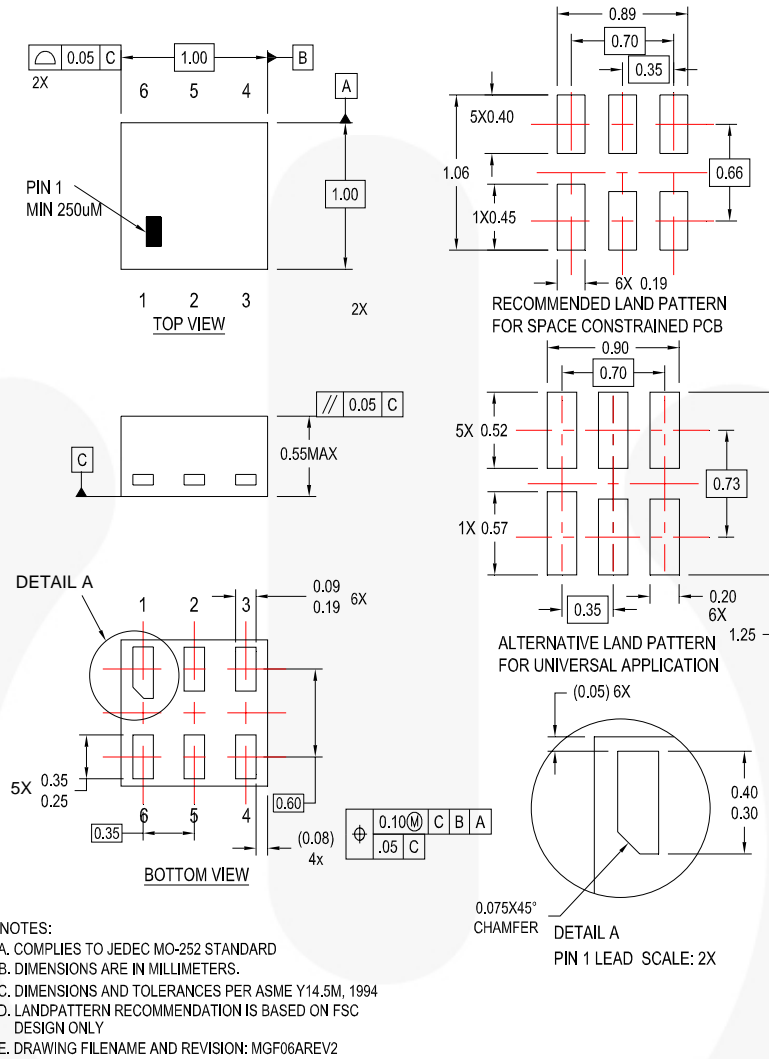


Figure 10.6-Lead, MicroPak2, 1x1mm Body, .35mm Pitch


