The list of part numbers in the attached file encompass the total list of part numbers which are being obsoleted from our portfolio. Original dates from PTN 165102 still apply. This decision is a result of an internal review and business decision to discontinue certain product offerings. The affected part numbers are listed in the attached table. Last Time Buy (LTB) and Last Time Ship (LTS) dates are provided for each product. The LTB date denotes the last day on which orders will be accepted; these orders may be scheduled for shipment through the LTS date provided.

The part listed as the “Drop-In Replacement” will perform the same task but with improved or revised technology. The part listed as the “Next Best Alternative” is the recommended replacement that may have some features or functions that are different and may require board re-design.

Note 1: The four parts listed with Note 1 are being closed immediately. The parts were opened in error as Cypress can only support shipments in Tape and Reel. The listed replacement part is the Tape and Reel ordering part number.
