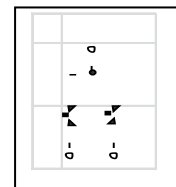

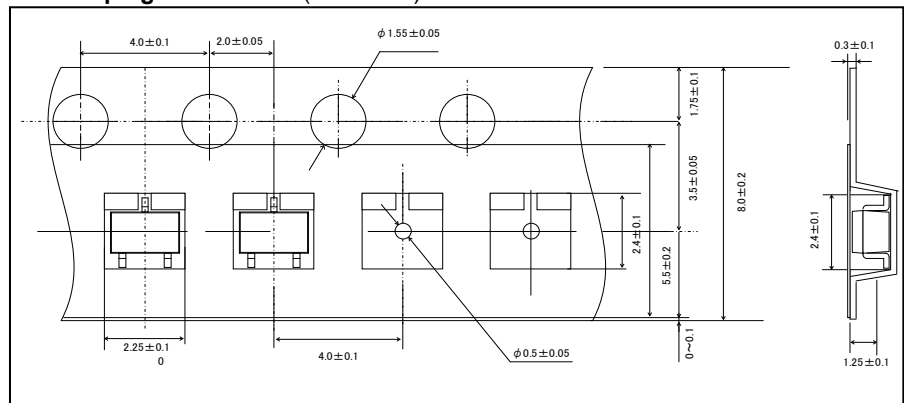

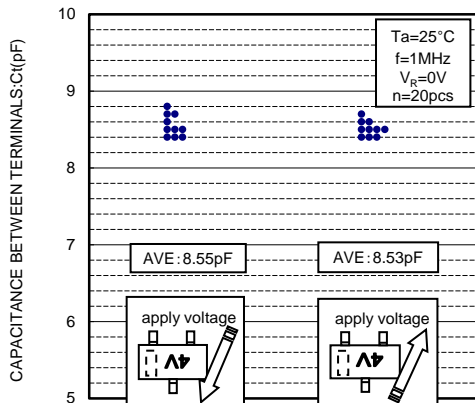




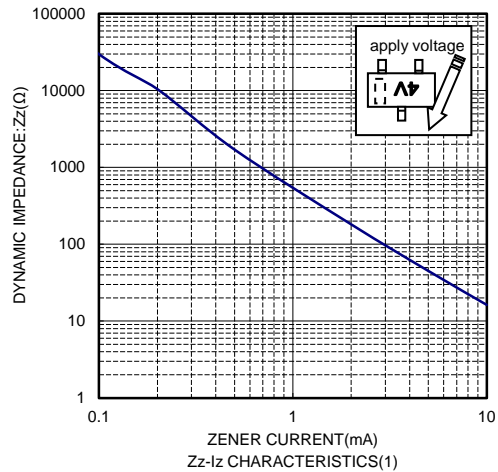
Zz DISPERSION MAP



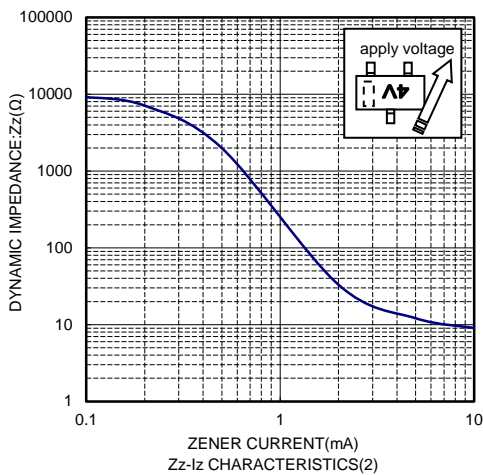
Izr DISPERSION MAP



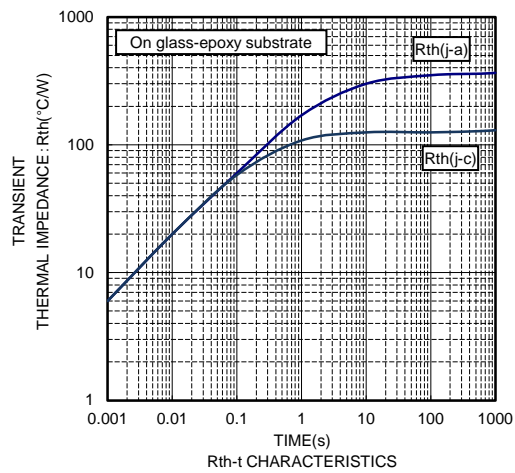
Ct DISPERSION MAP



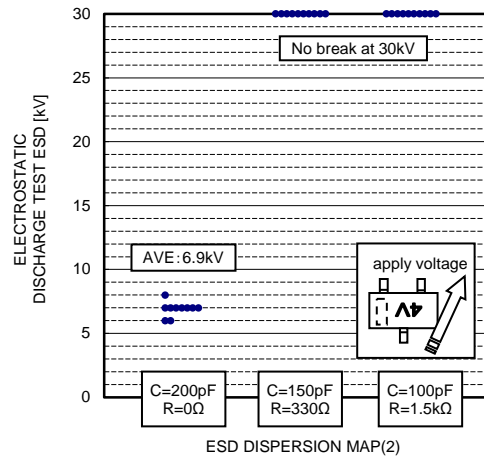
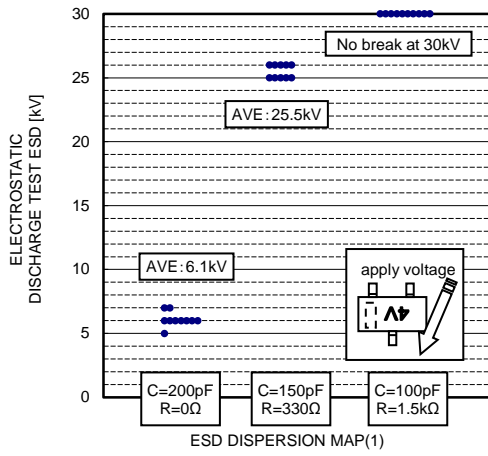
Zz-Iz CHARACTERISTICS(1)
