#### 4. FIRST AID MEASURES

### Potential Health Effects/Symptoms

**Inhalation:** Fumes evolved at soldering temperatures will irritate the nose, throat and lungs. Excessive inhalation of fumes from many metals can produce an acute reaction known as "metal fume fever". Symptoms consist of chills and fever (very similar to and easily confused with flu symptoms) which come on a few hours after large exposures. Inhalation of processing fumes may be harmful.

**Skin contact:** Causes skin irritation. May cause allergic skin reaction. Prolonged or repeated skin contact may cause irritation, skin sensitization and argyria (a non-toxic, cosmetic blue-gray discoloration of the skin and mucous membranes that is irreversible).

**Eye contact:** Causes serious eye irritation.

**Ingestion:** May cause gastrointestinal tract irritation if swallowed.
