Description of Change:

The purpose of this addendum is to announce the completion of the qualification and to correct the sample order part numbers.

Cypress announces the qualification of Cypress Philippines as an additional assembly site for select 48-Lead TSOP NAND FLASH products.

Benefit of Change:

Qualification of alternate manufacturing sites is part of the ongoing flexible manufacturing initiative announced by Cypress. The goal of the flexible manufacturing initiative is to provide the means for Cypress to continue to meet delivery commitments through dynamic, changing market conditions.

Approximate Implementation Date:

Effective 90 days from the date of this notification or upon customer approval, whichever comes first, all shipments of the affected part numbers in the attached file will be assembled at Cypress Philippines or other approved assembly sites.

Anticipated Impact:

Products assembled at the new site are completely compatible with existing products from a functional, parametric, and quality performance perspective.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

Method of Identification:

Cypress maintains traceability of product to wafer level, including wafer fabrication location, through the lot number marked on the package.
