Description of Change: Dear Customer, As you may be aware starting on 11DEC2017 the existing PV connector norm EN 50521 will expire. At that time, all PV connectors will be required to meet the EN 62852 norm. All of the norm changes will result in TE obtaining new TUV certification numbers for our products, however due to extreme limited sales on some product lines and the availability of an alternate and cheaper product, we've made the decision to obsolete the parts stated thereafter. As said, alternative products with improved specifications and performance are available and meet the new IEC 62852 norm, called PV4-S.

Reason: Discontinuance. To keep pace with the latest PV industrial norms and the continuously provide the best service to our valued customer, the end-of-life and switch to alternative products is ineluctable. We will do our best to work with you for smooth transition. Please evaluate the impact on panel/connector/cable certification ahead of time. At the moment, we already have the proposed alternative products available for testing and investigation, you can approach to our sales representative for information.
