4.1. Description of first aid measures

SECTION 5: Firefighting measures

5.1. Extinguishing media

5.3. Advice for firefighters

Methods for cleaning up

Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Approach the spillage from upwind. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. 7.1. Precautions for safe handling

Usage precautions

Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimise worker exposure.
