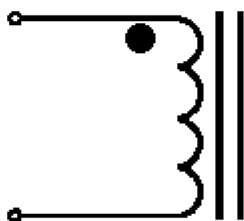

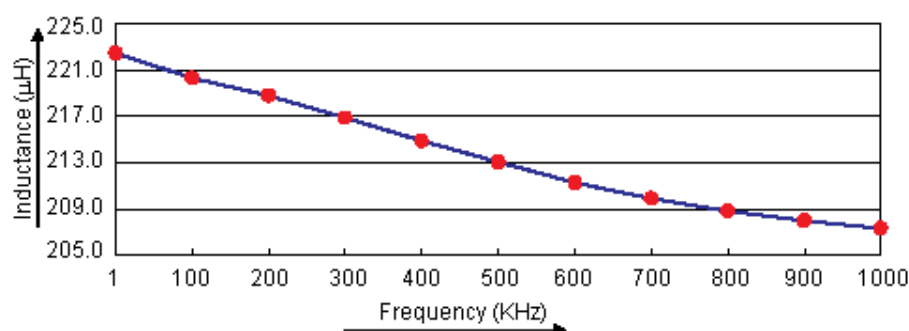
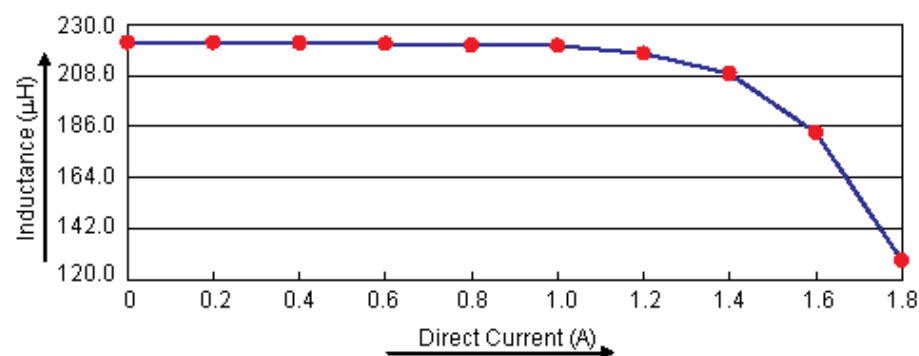
Schematic Diagram



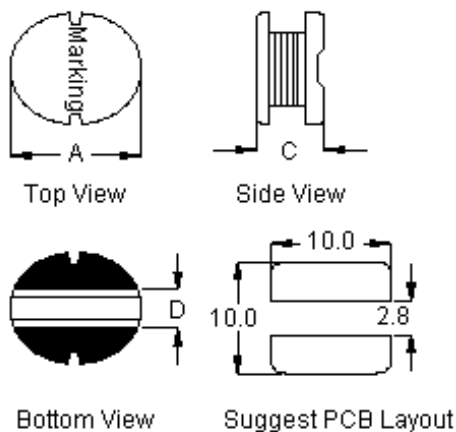
