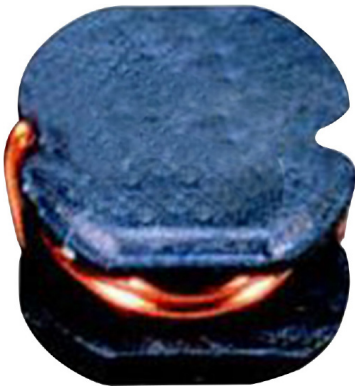

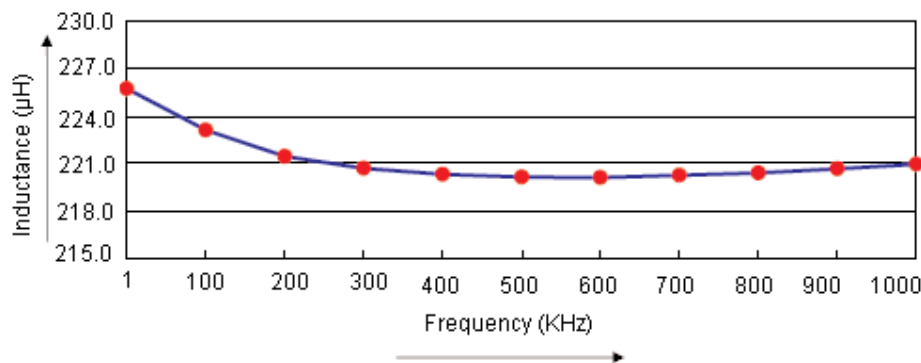
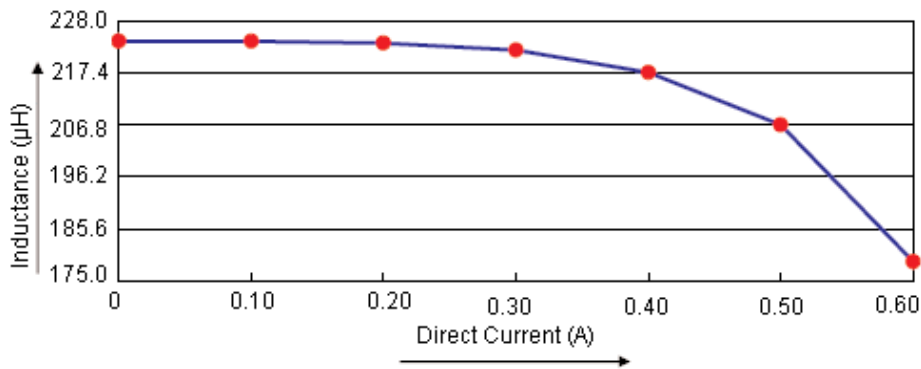
## Schematic Diagram



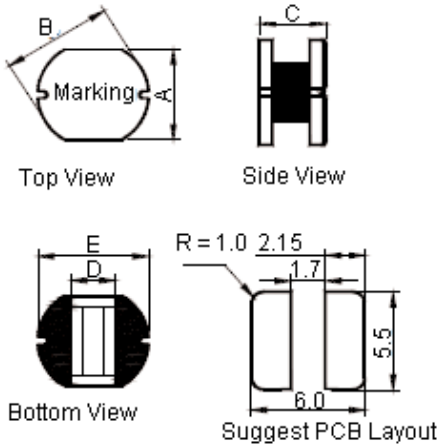
