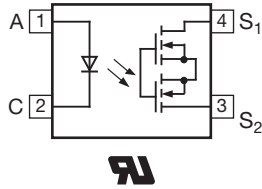


1 Form A Solid-State Relay (Normally Open)

DESCRIPTION

The LH1546AD is a single channel solid state relay in a 4 pin SMD package. It is a SPST normally open switch (1 Form A) that replaces electromechanical relays in many applications. It is constructed using a GaAlAs LED for actuation control and MOSFET switches for the output. In addition, it employs current-limiting circuitry to provide overvoltage protection.

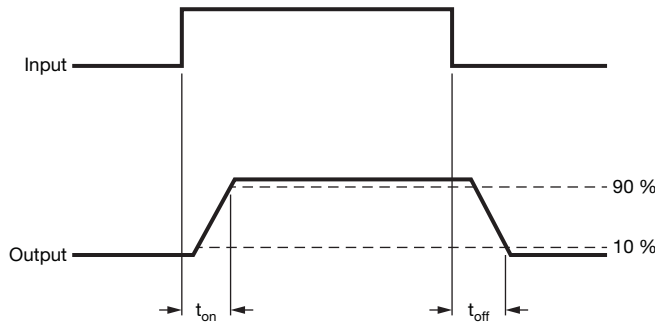
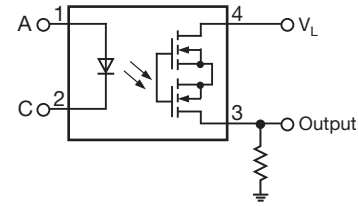


Fig. 1 - Timing Schematic

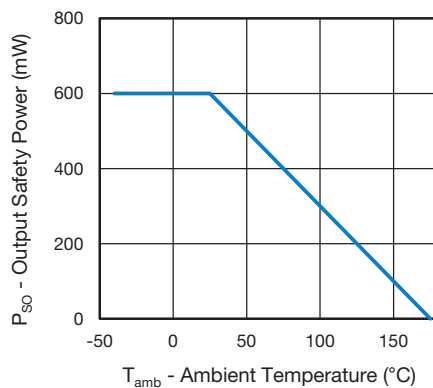


Fig. 2 - Safety Power Dissipation vs. Ambient Temperature

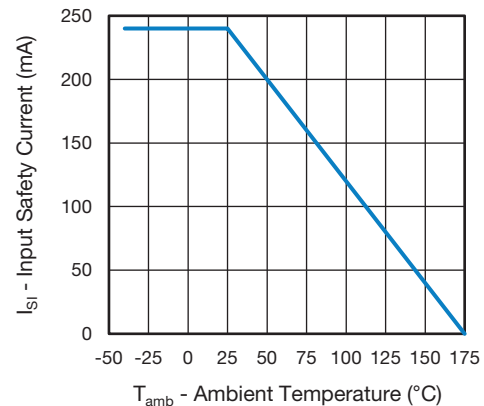


Fig. 3 - Safety Input Current vs. Ambient Temperature

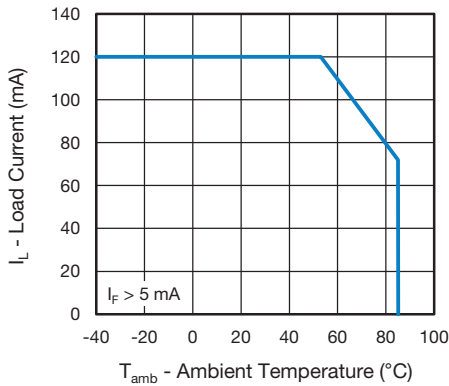


Fig. 4 - Maximum Load Current vs. Ambient Temperature

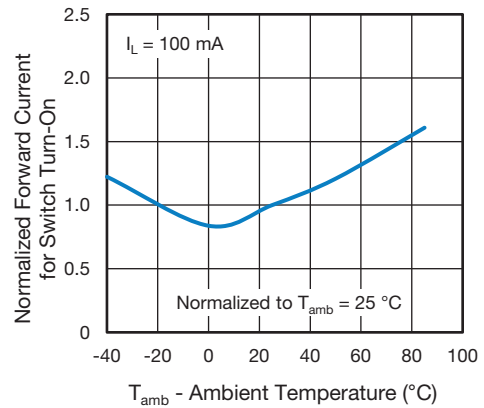


Fig. 7 - Normalized Forward Current for Switch Turn-On vs. Ambient Temperature

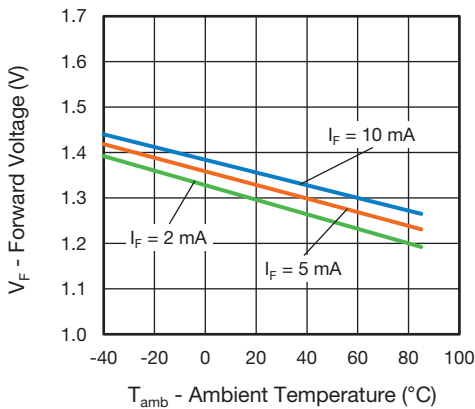


Fig. 5 - Forward Voltage vs. Ambient Temperature

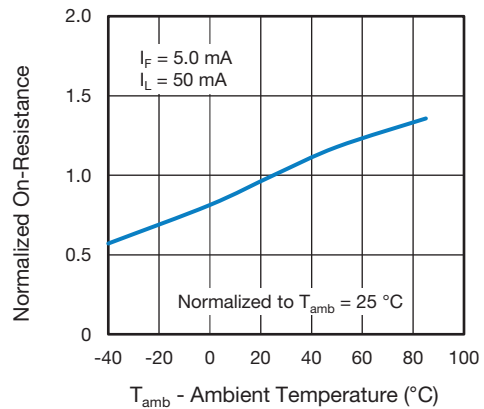


Fig. 8 - Normalized On-Resistance vs. Ambient Temperature

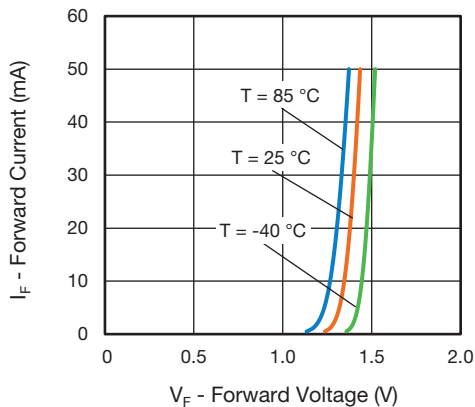


Fig. 6 - Forward Current vs. Forward Voltage

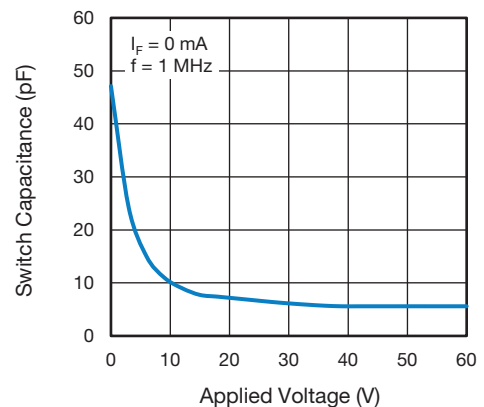


Fig. 9 - Switch Capacitance vs. Applied Voltage

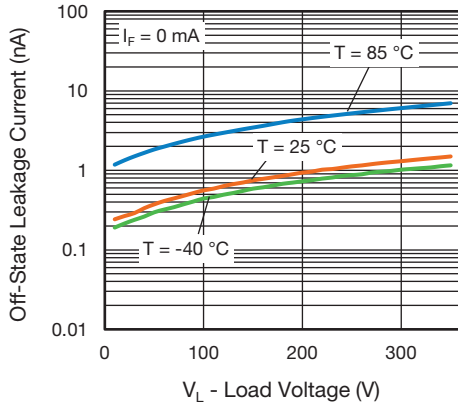


Fig. 10 - Off-State Leakage Current vs. Load Voltage

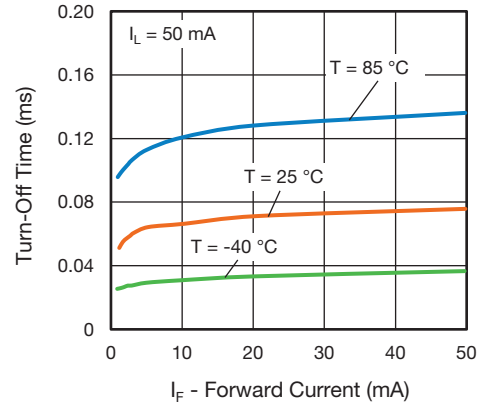


Fig. 13 - Turn-Off Time vs. Forward Current

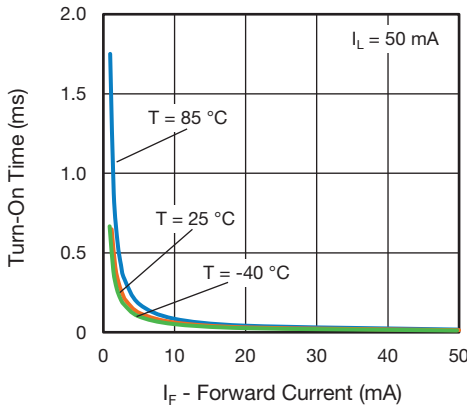


Fig. 11 - Turn-On Time vs. Forward Current

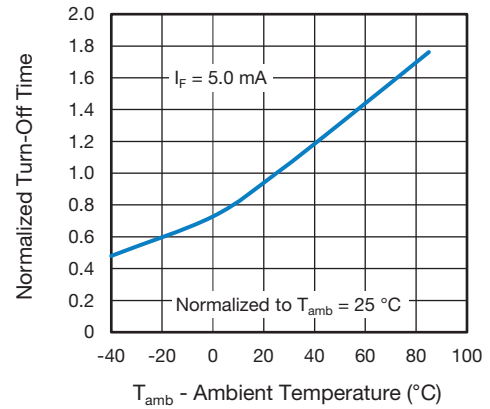


Fig. 14 - Normalized Turn-Off Time vs. Ambient Temperature

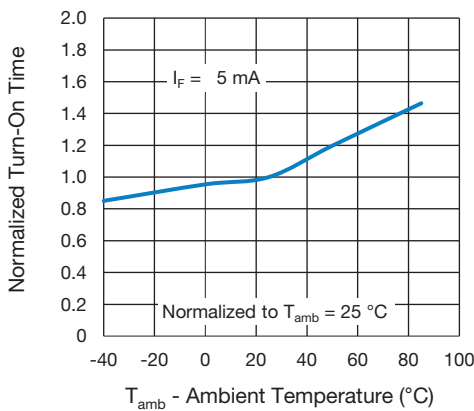
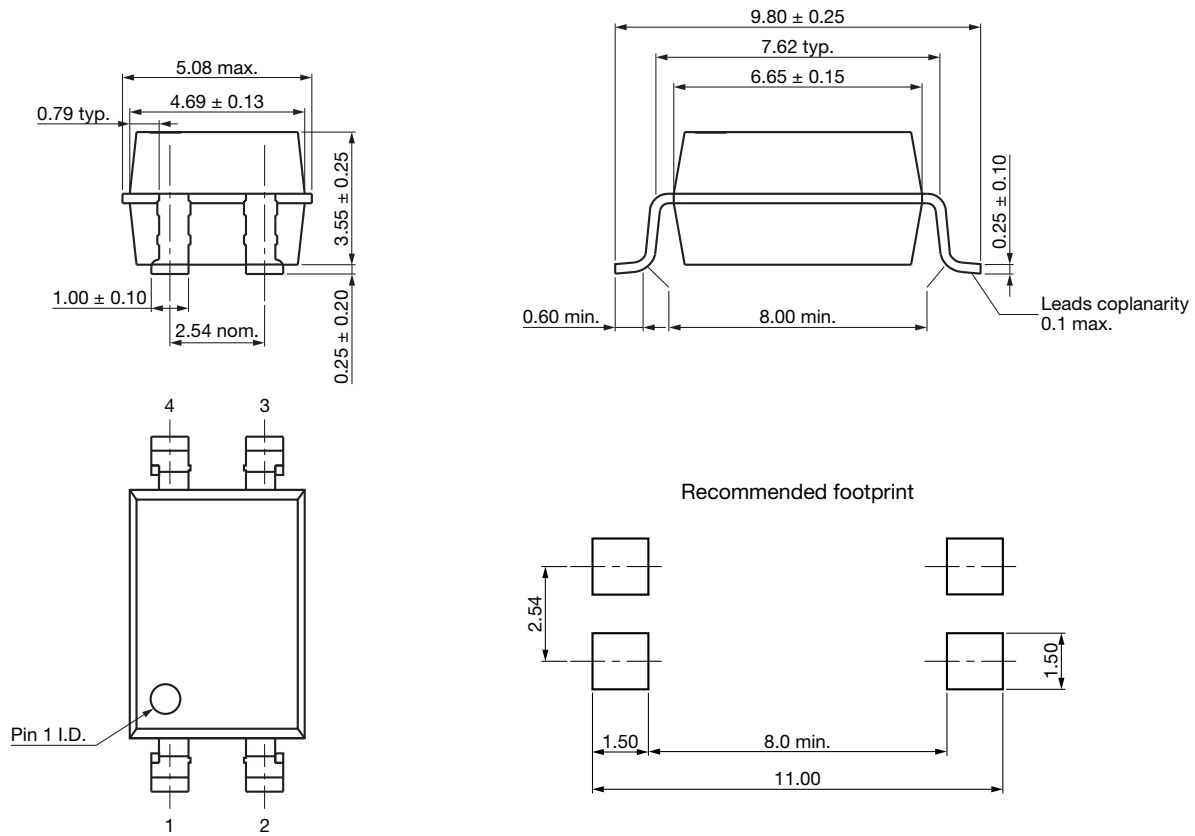


Fig. 12 - Normalized Turn-On Time vs. Ambient Temperature

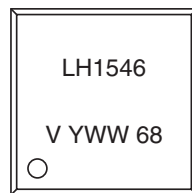


Fig. 15 - LH1546

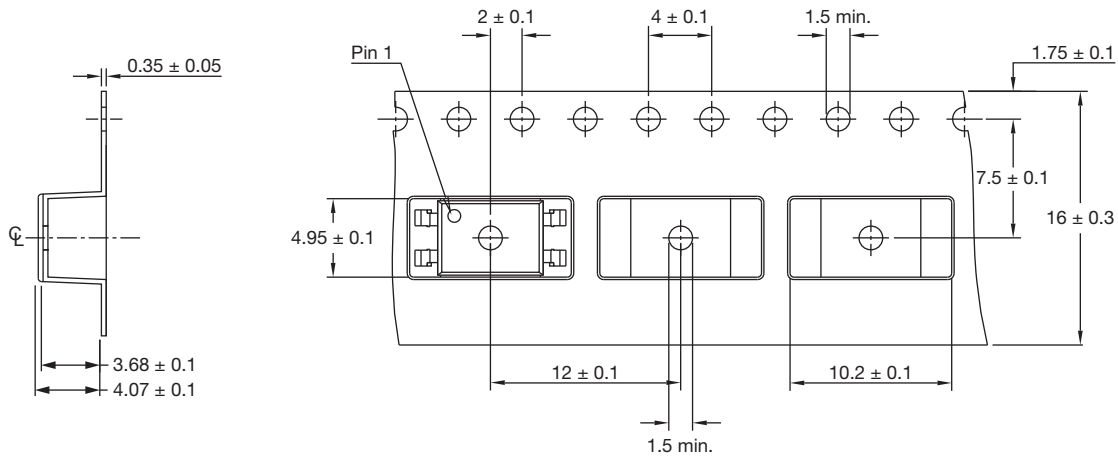


Fig. 16 - Tape and Reel Packing

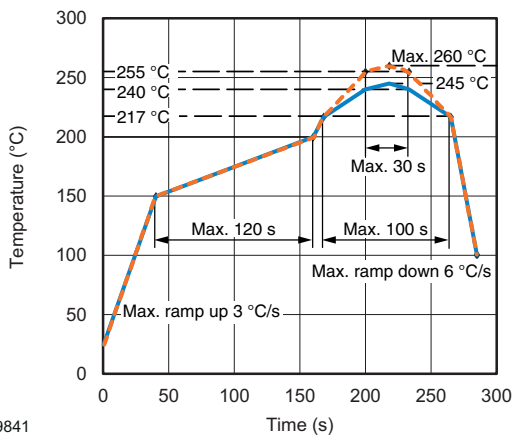


Fig. 17 - Lead (Pb)-free Reflow Solder Profile According to J-STD-020 for SMD Devices

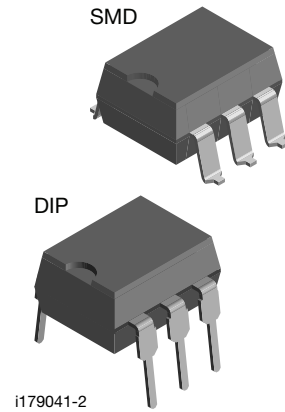
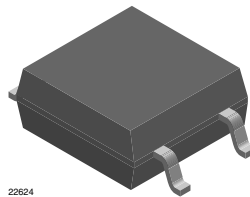
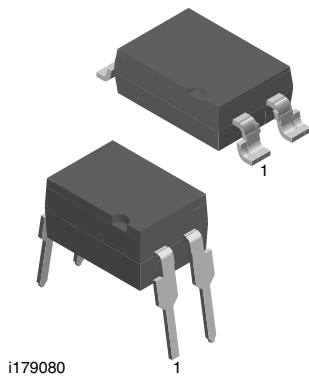
