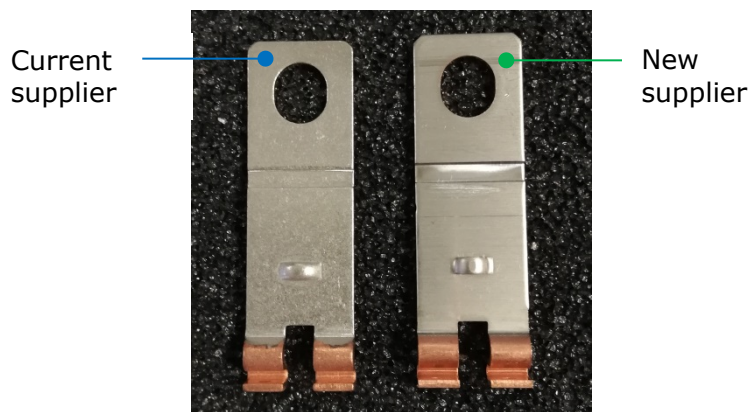

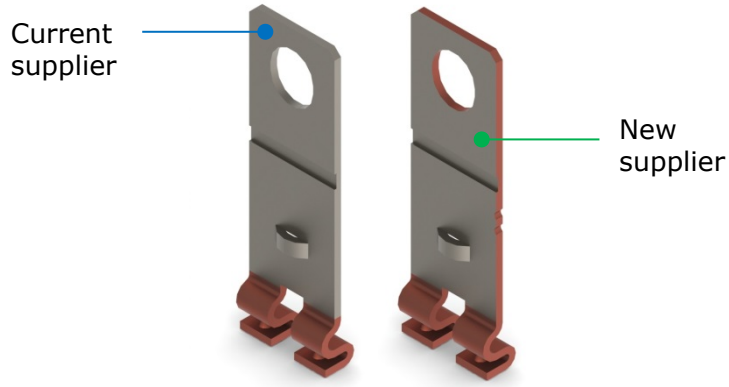
Subject of change: Nickel plated main terminals of SEMIPACK2

SEMIKRON product type: SKKD 152/16 H1, SKKD 212/16 H1

Description of change: Introduction of an alternative supplier for the main terminals. The material properties of the terminals remain unchanged. The Ni plating of terminals from the new supplier shows a different visual appearance which is only a cosmetic optical deviation with no impact on any relevant terminal properties.



At new supplier, the terminals are stamped from galvanized copper plates, similar to e.g. terminals of SEMIPACK 1. In consequence of this process, the terminal edges exhibit bare copper. This modification has no impact on any relevant terminal property.



Reason for change:	Securing of supply chain.
Impact of change:	No change of form, fit and function. Different optical appearance of the terminals from the new supplier.
Identification of change:	Traceable by lot number.
Time schedule for change:	Introduction in the production earliest by CW32/2020. Samples available upon request within 4 weeks from order intake.
