4.1. Description of first aid measures

Inhalation:

SECTION 5: Firefighting measures

5.1. Extinguishing media Suitable extinguishing media: Carbon dioxide, foam, powder Fine water spray

Engineering controls:

Ensure adequate ventilation, especially in confined areas. Extraction is necessary to remove fumes evolved during reflow. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction.
