Typical Impedance Characteristics:



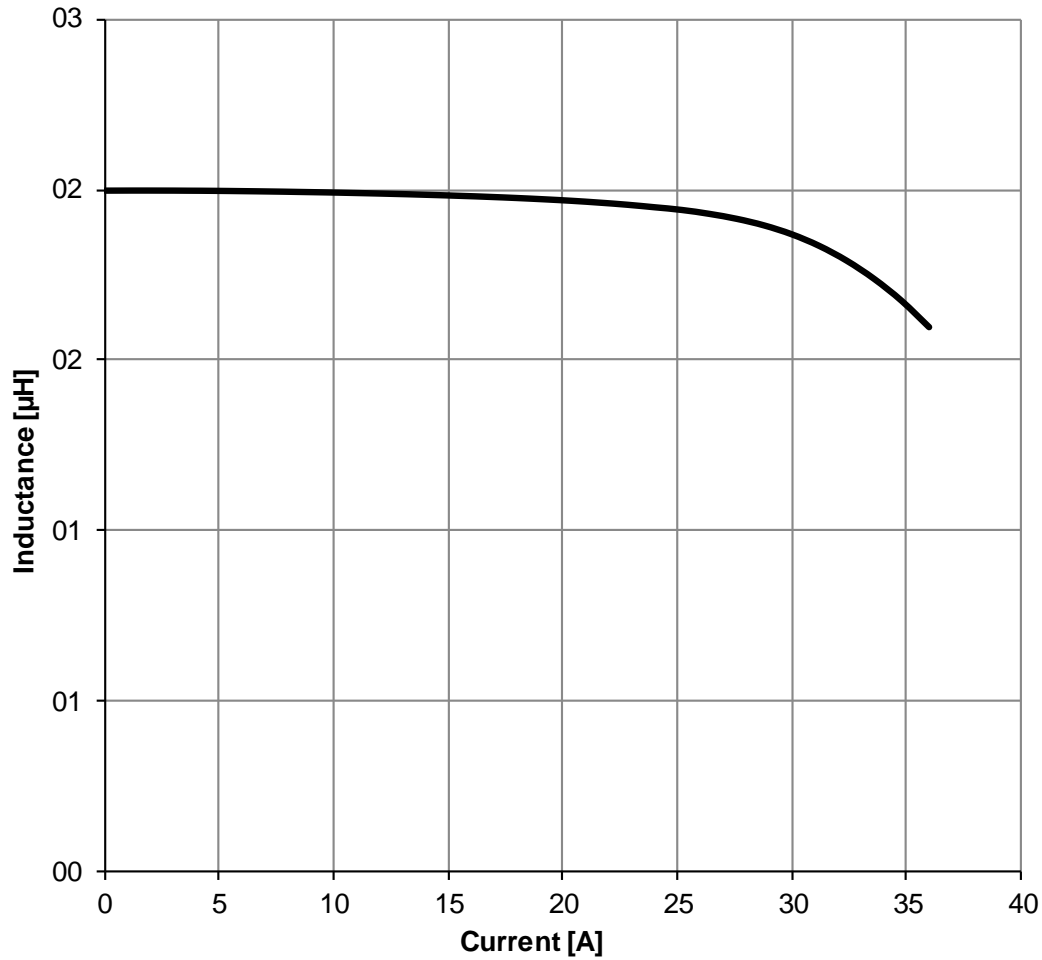
Typical Temperature Rise vs. Current Characteristics:

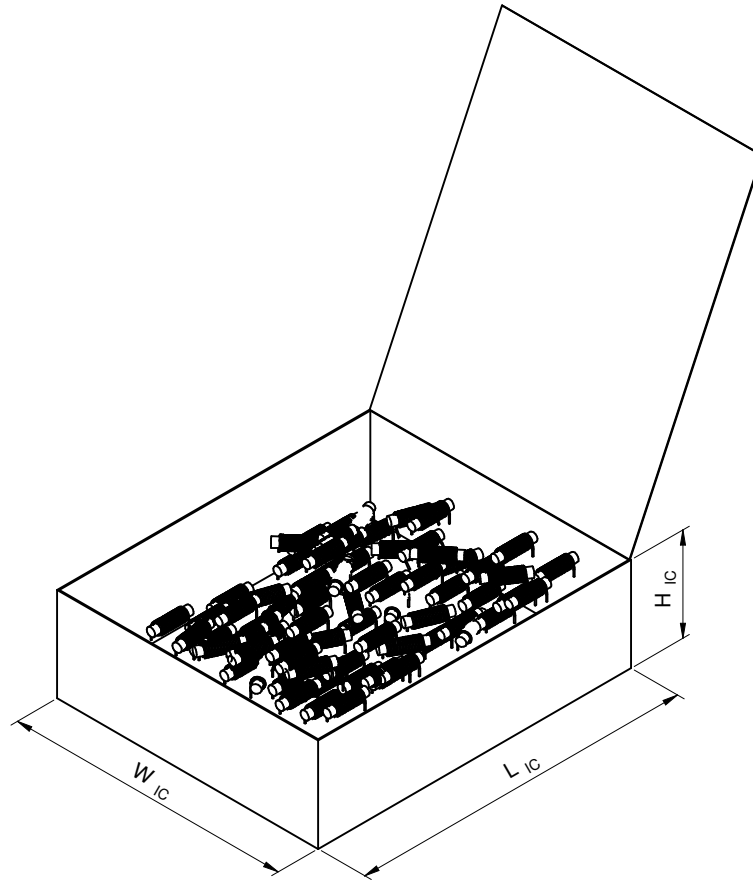

Typical Inductance vs. Current Characteristics:

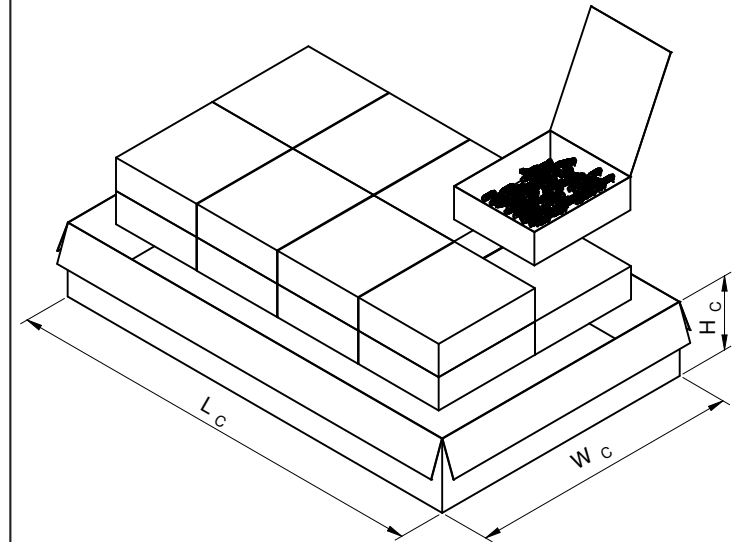





Storage Conditions:


