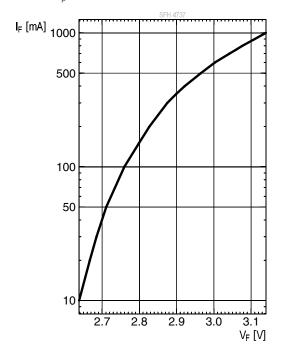

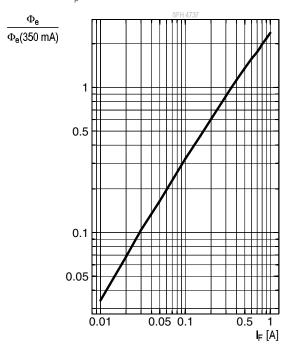

Component Location on Pad



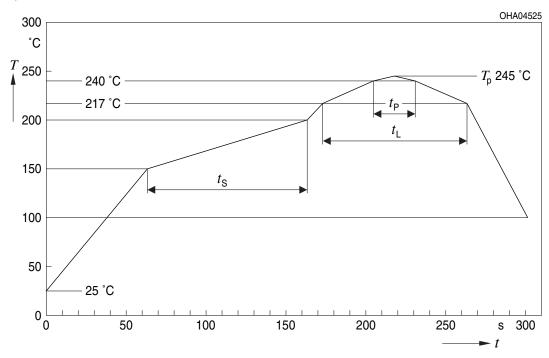

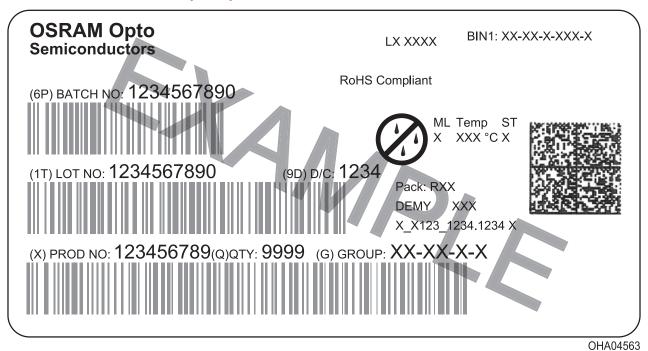
