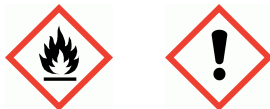

### 4.1. Description of first aid measures

### 5.1. Extinguishing media

### 5.3. Advice for firefighters

#### 6.1. Personal precautions, protective equipment and emergency procedures
