
DESCRIPTION

The PS2506-1 and PS2506L-1 are optically coupled isolator containing a GaAs light emitting diode and an NPN silicon darlington connected phototransistor.

The PS2506-1 is in a plastic DIP (Dual In-line Package) and the PS2506L-1 is lead bending type (Gull-wing) for surface mount.






PACKAGE DIMENSIONS (UNIT: mm)





Lead Bending Type For Surface Mount








*2. Test Circuit for Switching Time













TAPING SPECIFICATIONS (UNIT: mm)



(2) Wave soldering

2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between collector-emitters at startup, the output transistor may enter the on state, even if the voltage is within the absolute maximum ratings.

3. Measurement conditions of current transfer ratios (CTR), which differ according to photocoupler Check the setting values before use, since the forward current conditions at CTR measurement differ according to product.

When using products other than at the specified forward current, the characteristics curves may differ from the standard curves due to CTR value variations or the like. Therefore, check the characteristics under the actual operating conditions and thoroughly take variations or the like into consideration before use.





Dependence of maximum safety ratings with package temperature






Method a) Destructive Test, Type and Sample Test
