Bourns® Model SRN4018A Semi-shielded Inductor Series to be Discontinued

Riverside, California – June 4, 2021 – In accordance with our ongoing product lifecycle management procedure, Bourns will transfer the Model SRN4018A Semi-shielded Inductor Series to an End of Product Life status on November 15, 2021. A lack of sales volume and diminishing demand necessitates this action.

The [Model SRN4018TA Semi-shielded Inductor Series](#) is the recommended replacement for the discontinued series. The form, fit and function of the suggested replacement model series are not identical to the obsolete model series. However, the specifications of the suggested replacement Model SRN4018TA series are likely to be substitutable in typical applications. Please refer to Bourns' data sheets for more information.
