### Description of Changes

PNC as notify only, no PPAP required Due to recent Force Majeures within resin supply as well as new REACH regulations, TE is changing the resin used with the MCON connector family (for 13P, 26P, 28P and 40P) part numbers are listed in the information tab. The resin change is from the current supplier BASF PA66 material to the REACH compliant PA66 DPPD free material as the primary source to ensure material supply. TE will switch over via a running change based on material availability and consumption at the TE molding locations. Based on pre-approved OEM approvals and recommendations, this PCN is for notification only and the change does not require any OEM or TE part number changes; TE production drawings will be updated to call out DPPD free resin material. The new parts molded with DPPD free material will be identified with a new revision letter on the parts and/or coordinated with the date code.

#### Reason for Changes:

Document clarification. Due recent events with Force Majeure with chemicals, glass fibers, etc., TE is being forced to change to a DPPD free material for the BASF PA66 to allow BASF to allocate material and prevent resin shortages.
