




Fig. 6.3.1 Switching Time Test Circuit




Fig. 6.3.2 Input Waveform/Output Waveform




Fig. 8.9 t - I_D




Fig. 8.11 Safe Operating Area






Fig. 8.10 Dynamic Input Characteristics






