


# High Efficiency LED, Ø 5 mm Tinted Diffused Package




Fig. 1 - Forward Current vs. Ambient Temperature




Fig. 2 - Rel. Luminous Intensity vs. Angular Displacement




Fig. 3 - Relative Intensity vs. Wavelength




Fig. 4 - Forward Current vs. Forward Voltage




Fig. 5 - Relative Luminous Intensity vs. Forward Current




Fig. 6 - Relative Luminous Intensity vs. Ambient Temperature




