




Fig. 6.3.1 Test Circuit of Switching Time




Fig. 6.3.2 Input Waveform/Output Waveform

Note 2: Let  $V_{th}$  be the voltage applied between gate and source that causes the drain current (I<sub>D</sub>) to below (-1 mA for this device). Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . 




Fig. 7.1 Marking





Fig. 8.15 Safe Operating Area
