#### **GENERAL DESCRIPTION**

The EVAL-AD4129-8WARDZ evaluation kit features the AD4129-8 16-bit, ultra-low power, low noise analog-to-digital converter (ADC).

The EVAL-AD4129-8WARDZ board connects to the USB port of the PC by connecting to the EVAL-SDP-CK1Z motherboard. Regulate a 5 V USB supply through the PC to 3.3 V to supply the AD4129-8 and support all necessary components.

The AD4129-8 ACE Plugin fully configures the AD4129-8 device register functionality and provides DC time domain analysis as waveform graphs, histograms, and associated noise analysis for ADC performance evaluation.

The EVAL-AD4129-8WARDZ is an evaluation board that evaluates the features of the ADC. The user PC software executable controls the AD4129-8 over the USB through the EVAL-SDP-CK1Z System Demonstration Platform (SDP) board.

The product data sheet provides the full specifications of the AD4129-8. Consult the AD4129-8 data sheet in conjunction with this user guide when working with the EVAL-AD4129-8WARDZ evaluation board.

## EVAL-AD4129-8WARDZ BLOCK DIAGRAM




Figure 1. EVAL-AD4129-8WARDZ Block Diagram

## EVAL-AD4129-8WARDZ QUICK START GUIDE

To begin using the evaluation board, do the following:

- 1. Disconnect the EVAL-SDP-CK1Z board from the USB port of the PC.
- Install the ACE software, which can be downloaded at www.analog.com/ACE. Restart the PC after the software installation is complete. For complete software installation instructions, see the Evaluation Software section.
- Connect the EVAL-SDP-CK1Z board to the EVAL-AD4129-8WARDZ board.
- Screw the two boards together using the plastic screw and washer set (included in the evaluation board kit) to connect the boards firmly together.
- Connect the EVAL-SDP-CK1Z board to the PC using the supplied USB cable. If using Microsoft Windows<sup>®</sup> XP, search for the EVAL-SDP-CK1Z drivers. Choose to automatically search for the drivers for the EVAL-SDP-CK1Z board if prompted by the operating system.
- 6. From the **Programs** menu, go to the **Analog Devices** subfolder, and click ACE to launch the AD4129-8 ACE Plugin (see the Launching the Software section).




Figure 2. Hardware Configuration, Setting up the EVAL-AD4129-8WARDZ Evaluation Board
