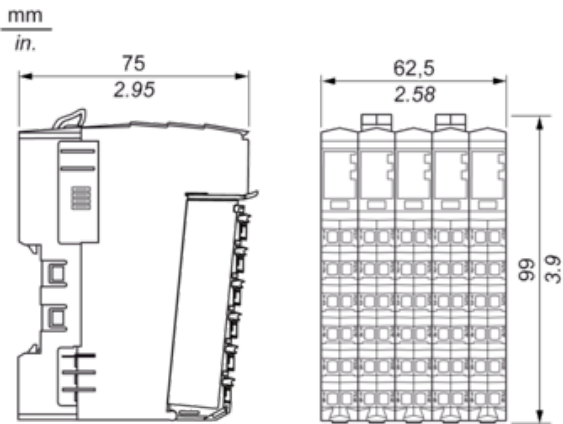

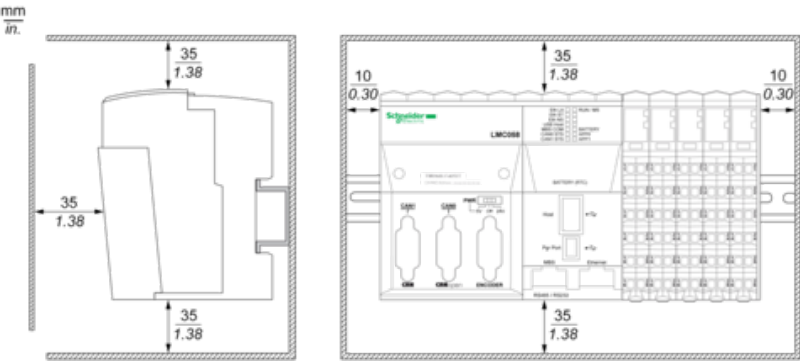

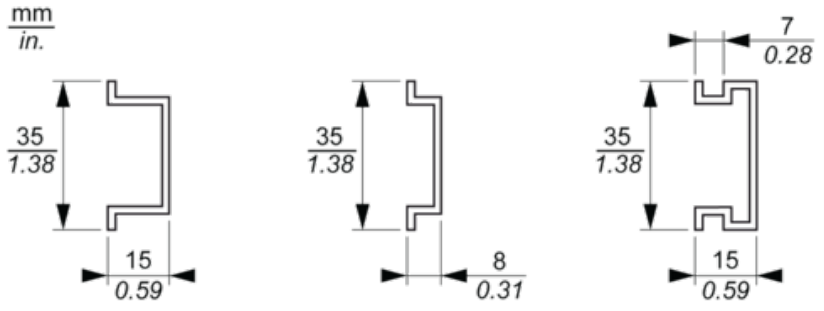

Mounting on a DIN Rail



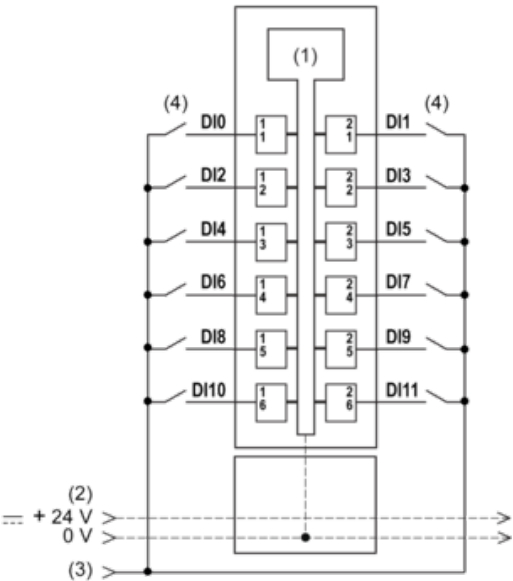

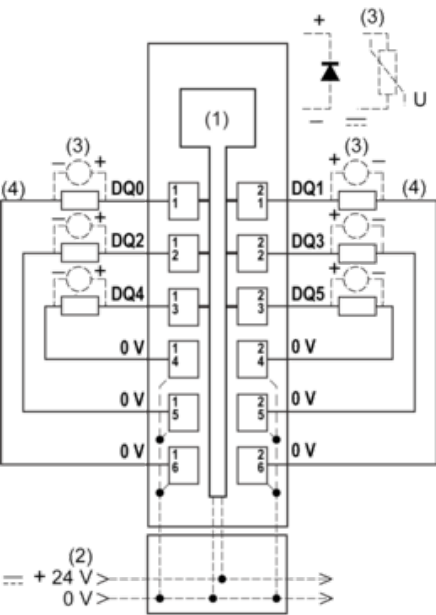
Wiring Diagram

- 4 2-wire sensor

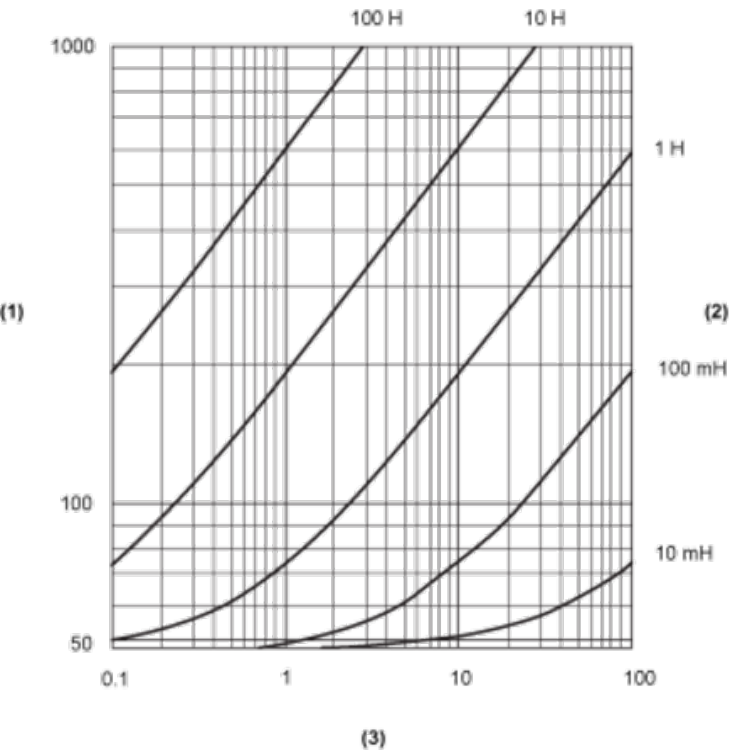
Digital Output 6Out
